#### A BILL ENTITLED

# 1 AN ACT concerning

# 2 Creation of a State Debt - Baltimore City - Concord Apartments

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$750,000,
- 4 the proceeds to be used as a grant to the Board of Directors of the Concord
- 5 Apartments, Inc. for certain development or improvement purposes; prohibiting
- 6 the use of the proceeds of the sale of the bonds and the matching fund for
- 7 sectarian religious purposes; providing for disbursement of the loan proceeds,
- 8 subject to a requirement that the grantee provide and expend a matching fund;
- and providing generally for the issuance and sale of bonds evidencing the loan.

# 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

# 11 MARYLAND, That:

- 12 (1) The Board of Public Works may borrow money and incur indebtedness on
- 13 behalf of the State of Maryland through a State loan to be known as the Baltimore
- 14 City Concord Apartments Loan of 2001 in a total principal amount equal to the
- 15 lesser of (i) \$750,000 or (ii) the amount of the matching fund provided in accordance
- 16 with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and
- 17 delivery of State general obligation bonds authorized by a resolution of the Board of
- 18 Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 19 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 20 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 21 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 22 § 8-122 of the State Finance and Procurement Article.
- 23 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 24 and first shall be applied to the payment of the expenses of issuing, selling, and
- 25 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 26 shall be credited on the books of the Comptroller and expended, on approval by the
- 27 Board of Public Works, for the following public purposes, including any applicable
- 28 architects' and engineers' fees: as a grant to the Board of Directors of the Concord
- 29 Apartments, Inc. (referred to hereafter in this Act as "the grantee") for the repair,
- 30 renovation, and reconstruction of an apartment building in Baltimore City for seniors
- 31 and disabled persons.

- 1 (4) An annual State tax is imposed on all assessable property in the State in 2 rate and amount sufficient to pay the principal of and interest on the bonds, as and 3 when due and until paid in full. The principal shall be discharged within 15 years 4 after the date of issuance of the bonds.
- 5 Prior to the payment of any funds under the provisions of this Act for the (5) 6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching fund. No part of the grantee's matching fund may be provided, either 8 directly or indirectly, from funds of the State, whether appropriated or 9 unappropriated. No part of the fund may consist of real property, in kind
- 10 contributions, or funds expended prior to the effective date of this Act. In case of any dispute as to the amount of the matching fund or what money or assets may qualify
- as matching funds, the Board of Public Works shall determine the matter and the
- 13 Board's decision is final. The grantee has until June 1, 2003, to present evidence
- 14 satisfactory to the Board of Public Works that a matching fund will be provided. If
- 15 satisfactory evidence is presented, the Board shall certify this fact and the amount of
- 16 the matching fund to the State Treasurer, and the proceeds of the loan equal to the
- amount of the matching fund shall be expended for the purposes provided in this Act.
- 18 Any amount of the loan in excess of the amount of the matching fund certified by the
- 19 Board of Public Works shall be canceled and be of no further effect.
- No portion of the proceeds of the loan or any of the matching funds may be 20 21 used for the furtherance of sectarian religious instruction, or in connection with the
- design, acquisition, or construction of any building used or to be used as a place of
- sectarian religious worship or instruction, or in connection with any program or
- 24 department of divinity for any religious denomination. Upon the request of the Board
- 25 of Public Works, the grantee shall submit evidence satisfactory to the Board that none
- 26 of the proceeds of the loan or any matching funds have been or are being used for a
- 27 purpose prohibited by this Act.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 28 29 June 1, 2001.
