- 3 FOR the purpose of altering the date by which the grantee is required to provide a
- 4 matching fund, pursuant to Chapter 233 of the Acts of the General Assembly of

- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 12 MARYLAND, That the Laws of Maryland read as follows:

13 Chapter 233 of the Acts of 1999

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That:
- 16 (5) Prior to the payment of any funds under the provisions of this Act for the
- 17 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 18 matching fund. No part of the grantee's matching fund may be provided, either
- 19 directly or indirectly, from funds of the State, whether appropriated or
- 20 unappropriated. No part of the fund may consist of real property or in kind
- 21 contributions. The fund may consist of funds, such as community block grants, that
- 22 have been expended prior to the effective date of this Act. In case of any dispute as to
- 23 the amount of the matching fund or what money or assets may qualify as matching
- 24 funds, the Board of Public Works shall determine the matter and the Board's decision
- 25 is final. The grantee has until June 1, [2001] 2002, to present evidence satisfactory to
- 26 the Board of Public Works that a matching fund will be provided. If satisfactory
- 27 evidence is presented, the Board shall certify this fact and the amount of the
- 28 matching fund to the State Treasurer, and the proceeds of the loan equal to the
- 29 amount of the matching fund shall be expended for the purposes provided in this Act.
- 30 Any amount of the loan in excess of the amount of the matching fund certified by the
- 31 Board of Public Works shall be canceled and be of no further effect.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 June 1, 2001.
