CHAPTER _____

1 AN ACT concerning

2 **Health Insurance - Colorectal Cancer Screening - Coverage**

3 FOR the purpose of requiring certain insurers, nonprofit health service plans, and
4 health maintenance organizations to provide coverage for colorectal cancer
5 screening in accordance with certain guidelines; authorizing certain insurers,
6 nonprofit health service plans, and health maintenance organizations to impose
7 certain cost-sharing requirements under certain circumstances; providing for
8 the application of this Act; and generally relating to requiring health insurance
9 coverage for colorectal cancer screening.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article - Insurance**

4 15-837.

5 (A) THIS SECTION APPLIES TO:

6 (1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE
7 HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS ON AN
8 EXPENSE-INCURRED BASIS UNDER HEALTH INSURANCE POLICIES OR CONTRACTS
9 THAT ARE ISSUED OR DELIVERED IN THE STATE; AND

10 (2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE HOSPITAL,
11 MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS UNDER CONTRACTS
12 THAT ARE ISSUED OR DELIVERED IN THE STATE.

13 (B) AN ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE COVERAGE FOR
14 COLORECTAL CANCER SCREENING IN ACCORDANCE WITH THE LATEST SCREENING
15 GUIDELINES ISSUED BY THE AMERICAN CANCER SOCIETY.

16 (C) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE COVERAGE
17 REQUIRED UNDER THIS SECTION MAY BE SUBJECT TO A COPAYMENT OR
18 COINSURANCE REQUIREMENT OR DEDUCTIBLE THAT AN ENTITY SUBJECT TO THIS
19 SECTION IMPOSES FOR SIMILAR COVERAGES UNDER THE SAME POLICY OR
20 CONTRACT.

21 (2) THE COPAYMENT OR COINSURANCE REQUIREMENT OR DEDUCTIBLE
22 IMPOSED UNDER PARAGRAPH (1) OF THIS SUBSECTION MAY NOT BE GREATER THAN
23 THE COPAYMENT OR COINSURANCE REQUIREMENT OR DEDUCTIBLE IMPOSED BY
24 THE ENTITY FOR SIMILAR COVERAGES.

25 (D) NOTHING IN THIS SECTION MAY BE CONSTRUED TO PROHIBIT AN ENTITY
26 SUBJECT TO THIS SECTION FROM PROVIDING COVERAGES THAT ARE GREATER THAN
27 OR MORE FAVORABLE TO AN INSURED OR ENROLLEE THAN THE COVERAGE
28 REQUIRED UNDER THIS SECTION.

31 (RR) THE PROVISIONS OF § 15-837 OF THE INSURANCE ARTICLE APPLY TO
32 HEALTH MAINTENANCE ORGANIZATIONS.

33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act applies to all
34 policies, contracts, and health benefits plans issued, delivered, or renewed in the
35 State on or after ~~October 1, 2001~~ June 1, 2001.

1 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 ~~October 1, 2004~~ June 1, 2001.
