A BILL ENTITLED

1 AN ACT concerning

2                                   **Creation of a State Debt - Maryland Consolidated Capital Bond Loan of 2001**  
3                                   **and the Maryland Consolidated Capital Bond Loans of 1997, 1998, 1999, and**  
4                                   **2000**

5 FOR the purpose of authorizing the creation of a State Debt in the amount of Four  
6    Hundred Fifty-One Million, Five Hundred Thousand Dollars (\$451,500,000) the  
7    proceeds to be used for certain necessary building, construction, demolition,  
8    planning, renovation, conversion, replacement, and capital equipment  
9    purchases of this State, for acquiring certain real estate in connection therewith,  
10   and for grants to certain subdivisions and other organizations for certain  
11   purposes, subject to the requirement that certain grantees provide certain  
12   matching funds of a certain type by a certain date; providing generally for the  
13   issuance and sale of bonds evidencing the loan; providing for certain  
14   unexpended appropriations in prior capital budgets and bond loan acts to be  
15   expended for other public projects; altering certain requirements for certain  
16   programs in prior capital budget acts; providing that the authorizations of State  
17   Debt in certain prior capital budget and bond loan acts be reduced by certain  
18   amounts; and generally relating to the financing of certain capital projects.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
2 MARYLAND, That:

3 (1) The Board of Public Works may borrow money and incur indebtedness on  
4 behalf of the State of Maryland through a State loan to be known as the Maryland  
5 Consolidated Capital Bond Loan of 2001 in the total principal amount of  
6 \$451,500,000. This loan shall be evidenced by the issuance, sale, and delivery of State  
7 general obligation bonds authorized by a resolution of the Board of Public Works and  
8 issued, sold, and delivered in accordance with Sections 8-117 through 8-124 of the  
9 State Finance and Procurement Article and Article 31, Section 22 of the Code.

10 (2) The bonds to evidence this loan or installments of this loan may be sold as  
11 a single issue of bonds under Section 8-122 of the State Finance and Procurement  
12 Article.

13 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer  
14 and first shall be applied to the payment of the expenses of issuing, selling, and  
15 delivering the bonds, unless funds for this purpose are otherwise provided, and then  
16 shall be credited on the books of the Comptroller and expended, on approval by the  
17 Board of Public Works, for the following public purposes, including any applicable  
18 architects' and engineers' fees:
