ON OR BEFORE DECEMBER 1 OF EACH YEAR, THE SECRETARY SHALL ISSUE A
REPORT TO THE GOVERNOR AND THE GENERAL ASSEMBLY, IN ACCORDANCE WITH §
2-1246 OF THE STATE GOVERNMENT ARTICLE, ON THE STATUS OF THE STROKE
PREVENTION, DETECTION, AND TREATMENT PROGRAM ESTABLISHED UNDER THIS
SUBTITLE.
