- 3 FOR the purpose of altering the process by which certain members of the Frederick
- 4 County Citizens Nursing Home Board are selected under certain circumstances;

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 18 MARYLAND, That the Laws of Maryland read as follows:

19 Article 25 - County Commissioners

- 21 (a) The board of county commissioners or county council of every county in
- 22 this State may establish a citizens nursing home board.
- 23 (b) (1) The board shall consist of ten members; and the initial members
- 24 shall be appointed by the county commissioners or county council; three members to
- 25 be appointed for three years, three for two years, three for one year.
- 26 (2) Members shall be chosen from among the residents of the county.

- 1 (3) One member of the board of county commissioners or county council 2 shall be a member of the board, ex officio, as chosen by the board of county 3 commissioners or county council from time to time. 4 Except as provided in [subparagraph] SUBPARAGRAPHS (ii) 5 AND (III) of this paragraph, as the terms of the initial appointees expire or as 6 vacancies occur, their successors shall be elected by a majority vote or quorum of the 7 board for terms of three years or the remainder thereof; and hereafter, these positions 8 shall be so filled. 9 In St. Mary's County, as the terms of the initial appointees (ii) 10 expire or as vacancies occur, their successors shall be appointed by the County 11 Commissioners of St. Mary's County for a term of 3 years if a term expires, or the rest 12 of the term if a term is vacated.
- 13 (III) IN FREDERICK COUNTY, AS THE TERMS OF THE INITIAL 14 APPOINTEES EXPIRE OR AS VACANCIES OCCUR, THEIR SUCCESSORS SHALL BE
- 15 APPOINTED BY THE COUNTY COMMISSIONERS OF FREDERICK COUNTY FOR A TERM 16 OF 3 YEARS IF A TERM EXPIRES, OR THE REST OF THE TERM IF A TERM IS VACATED.

- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 18 effect October 1, 2001.
