1 AN ACT concerning

2 **State Department of Education - Hearing Aid Loan Bank Program -**  
3 **Establishment and Operation**

4 FOR the purpose of establishing a Hearing Aid Loan Bank Program in the State  
5 Department of Education; providing for the administration and staffing of the  
6 Program; establishing the purpose of the Program; ~~requiring the State~~  
7 ~~Superintendent of Schools to provide benefits under the Program beginning by a~~  
8 ~~certain date~~; requiring the Director of the Program to establish a Hearing Aid  
9 Loan Bank; establishing certain criteria for the maintenance of the Hearing Aid  
10 Loan Bank; specifying certain criteria for eligibility under the Program;  
11 specifying certain conditions for borrowing a hearing aid under the Program;  
12 requiring the State Board of Education to adopt certain regulations; requiring  
13 that certain instructions be provided to a parent or legal guardian of an eligible  
14 child; requiring the Governor to include in the annual budget bill, ~~beginning in~~  
15 ~~a certain fiscal year~~, sufficient funds for the Program; requiring the State  
16 Superintendent to submit a certain annual report to the Governor and General

1 *Assembly*; defining certain terms; *providing for the termination of this Act*; and  
2 generally relating to the Hearing Aid Loan Bank Program for eligible children.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
10 MARYLAND, That the Laws of Maryland read as follows:

11 **Article - Education**

12 **SUBTITLE 5. HEARING AID LOAN BANK PROGRAM.**

13 8-501.

14 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
15 INDICATED.

16 (B) "DIRECTOR" MEANS THE DIRECTOR OF THE HEARING AID LOAN BANK  
17 PROGRAM.

18 (C) "ELIGIBLE CHILD" MEANS A CHILD WHO:

19 (1) IS A RESIDENT OF THE STATE;

20 (2) IS IDENTIFIED BY A LICENSED AUDIOLOGIST AS HAVING A HEARING  
21 LOSS;

22 (3) HAS NO IMMEDIATE ACCESS TO A HEARING AID; AND

23 (4) IS UNDER THE AGE OF 4 3 YEARS.

24 (D) "LICENSED AUDIOLOGIST" MEANS AN INDIVIDUAL WHO IS LICENSED TO  
25 PRACTICE AUDIOLOGY UNDER TITLE 2 OF THE HEALTH OCCUPATIONS ARTICLE.

26 (E) "LOAN BANK" MEANS THE HEARING AID LOAN BANK.

27 (F) "PROGRAM" MEANS THE HEARING AID LOAN BANK PROGRAM.

29 (A) THERE IS A HEARING AID LOAN BANK PROGRAM IN THE DEPARTMENT.

30 (B) THE PROGRAM IS ESTABLISHED FOR THE PURPOSE OF LENDING HEARING  
31 AIDS ON A TEMPORARY BASIS TO A PARENT OR LEGAL GUARDIAN OF AN ELIGIBLE  
32 CHILD TO ENSURE THAT CHILDREN UNDER THE AGE OF 4 3 YEARS WILL HAVE

1 MAXIMUM AUDITORY INPUT DURING THE CRITICAL PERIOD OF LANGUAGE  
2 LEARNING.

3 ~~(C) SUBJECT TO THE LIMITATIONS OF THE STATE BUDGET, THE STATE~~  
4 ~~SUPERINTENDENT SHALL PROVIDE BENEFITS UNDER THE PROGRAM BEGINNING~~  
5 ~~JULY 1, 2002.~~

7 (A) THE PROGRAM SHALL BE ADMINISTERED BY A DIRECTOR RECOMMENDED  
8 BY THE STATE SUPERINTENDENT AND APPROVED BY THE STATE BOARD.

9 (B) THE DIRECTOR SHALL:

10 (1) BE A LICENSED AUDIOLOGIST; AND

11 (2) SERVE AT THE PLEASURE OF THE STATE SUPERINTENDENT AND  
12 THE STATE BOARD.

13 (C) THE DIRECTOR MAY EMPLOY QUALIFIED STAFF AS PROVIDED FOR IN THE  
14 STATE BUDGET.

16 (A) THE DIRECTOR SHALL ESTABLISH A HEARING AID LOAN BANK.

17 (B) THE DIRECTOR SHALL PROVIDE AND MAINTAIN:

18 (1) A POOL OF HEARING AIDS IN THE LOAN BANK TO LEND TO A PARENT  
19 OR LEGAL GUARDIAN OF AN ELIGIBLE CHILD;

20 (2) TESTING AND PROGRAMMING EQUIPMENT FOR HEARING AIDS IN  
21 THE LOAN BANK; AND

22 (3) SUPPLIES FOR REPAIR AND RECONDITIONING OF HEARING AIDS IN  
23 THE LOAN BANK.

25 ~~(A) UPON RECEIPT OF A PRESCRIPTION FROM A LICENSED AUDIOLOGIST, THE~~  
26 ~~DIRECTOR SHALL LEND A SUITABLE HEARING AID TO A PARENT OR LEGAL~~  
27 ~~GUARDIAN OF AN ELIGIBLE CHILD UPON RECEIPT OF:~~

28 ~~(1) A PRESCRIPTION FROM A LICENSED AUDIOLOGIST; AND~~

29 ~~(2) ANY DOCUMENTS REQUIRED BY THE DIRECTOR TO PROVE THAT THE~~

31 (B) ~~(1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THE~~  
32 ~~LOAN PERIOD SHALL BE FOR NOT MORE THAN 6 MONTHS BUT MAY BE EXTENDED AT~~  
33 ~~THE DISCRETION OF THE DIRECTOR FOR ADDITIONAL 3-MONTH PERIODS.~~

1           (2)     THE DIRECTOR MAY EXTEND THE ORIGINAL LOAN PERIOD FOR  
 2 ADDITIONAL 3-MONTH PERIODS IF, PRIOR TO EACH EXTENSION, THE DIRECTOR  
 3 DETERMINES THAT:

4           (1)     THE CHILD DOES NOT HAVE IMMEDIATE ACCESS TO ANOTHER  
 5 HEARING AID UNDER MEDICAID, THE MARYLAND CHILDREN'S HEALTH PROGRAM, OR  
 6 PRIVATE HEALTH INSURANCE;

7           (II)    THE CHILD'S PARENT OR LEGAL GUARDIAN CURRENTLY DOES  
 8 NOT HAVE THE FINANCIAL MEANS TO OBTAIN IMMEDIATE ACCESS TO ANOTHER  
 9 HEARING AID; AND

10          (III)   THE CHILD'S PARENT OR LEGAL GUARDIAN IS MAKING  
 11 REASONABLE EFFORTS TO OBTAIN ACCESS TO ANOTHER HEARING AID.

12       (C)     A PARENT OR LEGAL GUARDIAN WHO BORROWS A HEARING AID FOR AN  
 13 ELIGIBLE CHILD SHALL:

14           (1)     ~~PROVIDE PROOF OF THE NEED FOR BENEFITS UNDER THE~~  
 15 ~~PROGRAM;~~

16           (2)     (1)     BE THE CUSTODIAN OF THE HEARING AID;

17           (3)     (2)     RETURN THE HEARING AID IMMEDIATELY TO THE LOAN BANK  
 18 UPON THE EXPIRATION OF THE LOAN PERIOD OR RECEIPT OF A SUITABLE  
 19 PERMANENT HEARING AID, WHICHEVER OCCURS FIRST;

20           (4)     (3)     BE RESPONSIBLE FOR THE PROPER CARE AND USE OF THE  
 21 HEARING AID;

22           (5)     (4)     BE RESPONSIBLE FOR ANY DAMAGE TO OR LOSS OF THE  
 23 HEARING AID; AND

24           (6)     (5)     SIGN A WRITTEN AGREEMENT PROVIDED BY THE STATE  
 25 SUPERINTENDENT THAT STATES THE TERM AND CONDITIONS OF THE LOAN.

26       (D)     THE DIRECTOR SHALL ENSURE THAT THE ELIGIBLE CHILD'S LICENSED  
 27 AUDIOLOGIST INSTRUCTS THE PARENT OR LEGAL GUARDIAN ABOUT THE PROPER  
 28 CARE AND USE OF A HEARING AID PROVIDED UNDER THE PROGRAM.

30     ~~THE GOVERNOR SHALL PROVIDE FUNDING FOR THE PROGRAM IN THE ANNUAL~~  
 31 ~~BUDGET OF THE DEPARTMENT BEGINNING IN FISCAL YEAR 2003 IN AN AMOUNT~~ THE  
 32 GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION THAT  
 33 IS SUFFICIENT TO COVER THE ESTIMATED COST OF THE PROGRAM.

35     THE STATE BOARD SHALL ADOPT REGULATIONS TO IMPLEMENT THE  
 36 PROVISIONS OF THIS SUBTITLE, INCLUDING REGULATIONS THAT:

1 (1) FOR THE PURPOSE OF IMPLEMENTING § 8-505(A) OF THIS SUBTITLE,  
2 IDENTIFY THE TYPES OF DOCUMENTS THAT THE DIRECTOR MAY REQUIRE A PARENT  
3 OR LEGAL GUARDIAN TO SUBMIT TO PROVE THAT A CHILD IS AN ELIGIBLE CHILD;  
4 AND

5 (2) FOR THE PURPOSE OF IMPLEMENTING § 8-505(B)(2) OF THIS  
6 SUBTITLE, ESTABLISH FACTORS THAT THE DIRECTOR SHALL CONSIDER WHEN  
7 EVALUATING WHETHER A PARENT OR LEGAL GUARDIAN:

8 (I) HAS THE FINANCIAL MEANS TO OBTAIN IMMEDIATE ACCESS  
9 TO ANOTHER HEARING AID; OR

10 (II) IS MAKING REASONABLE EFFORTS TO OBTAIN IMMEDIATE  
11 ACCESS TO ANOTHER HEARING AID.

13 (A) BEGINNING IN 2002, NO LATER THAN DECEMBER 31 OF EACH YEAR, THE  
14 STATE SUPERINTENDENT SHALL SUBMIT AN ANNUAL REPORT TO THE GOVERNOR  
15 AND, SUBJECT TO § 2-1246 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL  
16 ASSEMBLY REGARDING THE IMPLEMENTATION OF THIS SUBTITLE.

17 (B) THE ANNUAL REPORT SHALL INCLUDE THE FOLLOWING INFORMATION:

18 (1) THE NUMBER AND AGES OF CHILDREN WHO RECEIVED HEARING  
19 AIDS THROUGH THE LOAN PROGRAM THAT YEAR;

20 (2) THE NUMBER OF CHILDREN WHO RECEIVED HEARING AIDS  
21 THROUGH THE LOAN PROGRAM THAT YEAR AND SUBSEQUENTLY RECEIVED  
22 HEARING AIDS THROUGH MEDICAID, THE MARYLAND CHILDREN'S HEALTH  
23 PROGRAM, OR PRIVATE INSURANCE;

24 (3) THE LENGTH OF EACH ORIGINAL LOAN;

25 (4) THE NUMBER OF TIMES THAT EACH ORIGINAL LOAN WAS EXTENDED  
26 AND THE LENGTH OF EACH EXTENSION;

27 (5) THE NUMBER OF TIMES THAT HEARING AIDS WERE NOT PROPERLY  
28 RETURNED TO THE LOAN BANK; AND

29 (6) ANY OTHER INFORMATION THAT THE STATE SUPERINTENDENT  
30 BELIEVES IS RELEVANT TO EVALUATING THE COSTS AND BENEFITS OF THE  
31 PROGRAM.

32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
33 October 1, June 30, 2001. It shall remain effective for a period of 3 years and 1 day  
34 and, at the end of June 30, 2004, with no further action required by the General  
35 Assembly, this Act shall be abrogated and of no further force and effect.
