- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:
- 14 Article Real Property
- 15 12-104.1.
- 16 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS 17 INDICATED.
- 18 (2) "BUSINESS" MEANS A LAWFUL ACTIVITY, WHETHER OR NOT FOR
- 19 PROFIT, OTHER THAN A FARM OPERATION, CONDUCTED PRIMARILY FOR THE
- 20 PURCHASE, SALE, LEASE, RENTAL, MANUFACTURE, PROCESSING, OR MARKETING OF
- 21 PRODUCTS, COMMODITIES, OR OTHER PROPERTY, OR FOR PROVIDING SERVICES.
- 22 (3) "GOODWILL" MEANS THE BENEFITS THAT ACCRUE TO A BUSINESS AS
- 23 A RESULT OF ITS LOCATION, REPUTATION FOR DEPENDABILITY, SKILL, OR QUALITY,
- 24 AND ANY OTHER CIRCUMSTANCES RESULTING IN PROBABLE RETENTION OF OLD OR
- 25 ACQUISITION OF NEW PATRONAGE.
- 26 (B) IN ADDITION TO FAIR MARKET VALUE DETERMINED UNDER § 12-105 OF
- 27 THIS SUBTITLE, THE OWNER OF A BUSINESS CONDUCTED ON PROPERTY TAKEN, OR

- 1 ON THE REMAINDER IF THERE IS A PARTIAL TAKING, SHALL BE COMPENSATED FOR 2 LOSS OF GOODWILL ONLY IF THE OWNER PROVES THAT THE LOSS:
- 3 (1) IS CAUSED BY THE TAKING OF THE PROPERTY OR THE INJURY TO 4 THE REMAINDER;
- 5 (2) CANNOT REASONABLY BE PREVENTED BY A RELOCATION OF THE
- 6 BUSINESS OR BY TAKING STEPS AND ADOPTING PROCEDURES THAT A REASONABLY
- 7 PRUDENT PERSON WOULD TAKE AND ADOPT IN PRESERVING GOODWILL;
- $8 \hspace{1cm}$ (3) WILL NOT BE INCLUDED IN RELOCATION PAYMENTS UNDER \S 12-205 9 OF THIS TITLE; AND
- 10 (4) WILL NOT BE DUPLICATED IN THE COMPENSATION AWARDED TO 11 THE OWNER.
- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
- 13 construed only prospectively and may not be applied or interpreted to have any effect
- 14 on or application to any case filed before the effective date of this Act.
- 15 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 16 October 1, 2001.
