- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:
- 16 Article 12 Garrett County
- 17 20-8.1.
- 18 THE COUNTY COMMISSIONERS OF GARRETT COUNTY SHALL APPOINT A
- 19 SUPERVISOR OF TAX COLLECTION WHO SHALL EXECUTE THE REQUIRED BOND OR
- 20 BONDS AND QUALIFY AS SPECIFIED UNDER THE PROVISIONS OF CHAPTER 110. THE
- 21 SUPERVISOR OF TAX COLLECTION SHALL BE EMPLOYED UNDER THE PROVISIONS OF
- 22 THE RULES AND REGULATIONS OF THE CLASSIFIED SERVICE OF GARRETT COUNTY.
- 23 66-8.
- 24 C. Such tax shall be due and payable monthly to the [Treasurer] DIRECTOR
- 25 OF FINANCE of Allegany COUNTY and THE SUPERVISOR OF TAX COLLECTION OF
- 26 Garrett [Counties] COUNTY, respectively, in which the mine is operated, and payable
- 27 on or before the 25th day of the month next succeeding the month for which such tax
- 28 is payable. In order to secure the effectual payments of such tax, each operator is
- 29 authorized and required to deduct and retain from the wages of each employee
- 30 employed by him on his payrolls in Allegany County the sum of twenty-seven cents
- 31 (\$0.27) and in Garrett County the sum of thirty-eight cents (\$0.38) per month or
- 32 fraction of a month if said employee is employed for less than a month. On or before
- 33 the 15th day of the month next [sucedding] SUCCEEDING the month for which such
- 34 deduction is made, each operator shall make a report of the number of employees so
- 35 employed, under oath, to the [Treasurers] DIRECTOR OF FINANCE of Allegany
- 36 COUNTY or THE SUPERVISOR OF TAX COLLECTION OF Garrett [Counties] COUNTY
- 37 where the particular mine is located, and, on or before the 25th day of said succeeding
- 38 month, shall pay over unto the [Treasurer] DIRECTOR OF FINANCE of Allegany
- 39 COUNTY or THE SUPERVISOR OF TAX COLLECTION OF Garrett County, as the case

- 1 may be, the total amount so deducted and retained from the wages of the employees
- 2 for the preceding month, together with a like amount to be paid by the operator. It
- 3 shall be the duty of the County Commissioners of Allegany and Garrett Counties,
- 4 respectively, to enforce, by appropriate remedies, the collection and payment of the
- 5 tax hereby levied, and to all taxes in default, there shall be added and collected
- 6 interest at the rate of six percent (6%) per annum from the date when due.

- 8 A. The [Treasurers] DIRECTOR OF FINANCE of Allegany COUNTY and THE
- 9 SUPERVISOR OF TAX COLLECTION OF Garrett [Counties] COUNTY shall be legally
- 10 liable to the respective Boards of County Commissioners for the safe and proper
- 11 custody of the moneys received by them under this Article and shall hold the same in
- 12 a separate fund to be known as "Miners and Operators Co-Operative Relief Fund,"
- 13 and shall only draw upon said Fund as provided by this Article.
- 14 B. (1) The respective Boards of County Commissioners may award the
- 15 [Treasurers] DIRECTOR OF FINANCE OF ALLEGANY COUNTY AND THE SUPERVISOR
- 16 OF TAX COLLECTION OF GARRETT COUNTY, in compensation for their services
- 17 hereunder, such amounts as follows:
- 18 (a) For the [Treasurer] SUPERVISOR OF TAX COLLECTION in

- 22 (2) The compensation shall be paid out of the general revenues of the

- 24 C. The [Treasurers] DIRECTOR OF FINANCE IN ALLEGANY COUNTY AND THE
- 25 SUPERVISOR OF TAX COLLECTION IN GARRETT COUNTY shall each keep careful
- 26 statistics of the operations of this function, prepare and submit monthly, in advance,
- 27 to the operators forms for their reports and himself make monthly reports on or before
- 28 the first day of each month of the operation of the same to the County Commissioners
- 29 of his county, stating receipts, disbursements and such other facts as may be
- 30 necessary to correctly present the status of the Fund.
- D. The [Treasurer] DIRECTOR OF FINANCE of Allegany County shall give
- 32 bond to the State of Maryland in the sum of twenty-five thousand dollars (\$25,000.)
- 33 and in such further sums as may from time to time be fixed by the County
- 34 Commissioners of said county, and the [Treasurer] SUPERVISOR OF TAX COLLECTION
- 35 of Garrett County shall give bond to the State of Maryland in the sum of five
- 36 thousand dollars (\$5,000.) and in such further sum as may from time to time be fixed
- 37 by the County Commissioners of [said] EACH county, to secure the faithful
- 38 performance of their duties, and such bonds shall be approved by the County
- 39 Commissioners and the cost thereof shall be charged to the Fund.

- The [legal voters of said Garrett County shall, on the Tuesday after the first
- 4 Monday in November 1930 and on the same day and month in every fourth year
- 5 thereafter, elect a suitable] COUNTY COMMISSIONERS OF GARRETT COUNTY SHALL
- 6 APPOINT A SUPERVISOR OF TAX COLLECTION WHO SHALL BE A person of good repute
- 7 and fit business capacity to be [County Treasurer] SUPERVISOR OF TAX COLLECTION
- 8 for [said county,] THE COUNTY AND who shall execute the required bond or bonds
- 9 and qualify in the manner hereinafter [provided and shall hold his office commencing
- 10 on January 1 following such election for four years or until his successor shall be
- 11 elected and qualified, and said person shall be ineligible for four years thereafter for
- 12 election to the same office; provided, however, that this provision shall not apply in
- 13 the event of the election of a Treasurer by the County Commissioners to fill a vacancy
- 14 as provided by § 110-4D of this chapter.] PROVIDED. THE SUPERVISOR OF TAX
- 15 COLLECTION SHALL BE AN EMPLOYEE OF THE COUNTY UNDER RULES AND
- 16 REGULATIONS OF THE CLASSIFIED SERVICE OF GARRETT COUNTY.

- 18 The [County Treasurer] SUPERVISOR OF TAX COLLECTION shall be the collector
- 19 of all state and county taxes for whatever purpose levied or to be levied for within
- 20 [said] THE county [during his term of office] or that may be placed in his hands for
- 21 collection, and he shall have full power and it shall be his bounden duty to receive and
- 22 collect all state and county taxes levied as aforesaid and so placed in his hands for
- 23 collection and all moneys which may be due [said] THE county, with full power to
- 24 enforce the payment of the same by sale or otherwise as hereinafter prescribed and to
- 25 convey to any purchaser by a good and sufficient deed any real or personal property
- 26 sold by him for the payment of any state or county taxes, or both, in the manner
- 27 provided in this chapter.

- 29 The [Treasurer] SUPERVISOR OF TAX COLLECTION shall be subject to
- 30 [removal] DISMISSAL from office at all times by the [Judges of the Circuit Court for]
- 31 COUNTY COMMISSIONERS OF Garrett County [upon conviction for willful neglect of
- 32 duty or misdemeanor] FOR INEFFICIENCY, ANY WILLFUL NEGLECT OF DUTY, or
- 33 misbehavior in office. THE SUPERVISOR OF TAX COLLECTION IS ALSO SUBJECT TO
- 34 DISCIPLINE OR DISMISSAL FOR A VIOLATION OF THE RULES AND REGULATIONS
- 35 GOVERNING THE CLASSIFIED SERVICE OF GARRETT COUNTY.
- 36 110-4.
- A. [The person elected Treasurer, before he enters upon the duties of his
- 38 said] BEFORE ASSUMING THE DUTIES OF THE office, THE SUPERVISOR OF TAX
- 39 COLLECTION shall take an oath before the Clerk of the Circuit Court for [said
- 40 county] GARRETT COUNTY in form similar to that taken by collectors of taxes, except
- 41 as to the title of his office, and shall be similarly certified.

- 1 B. [He] THE SUPERVISOR OF TAX COLLECTION shall execute to the State of
- 2 Maryland such bond as is now or may hereafter be required by law as the Collector of
- 3 State Taxes, which bond shall be approved and filed in like manner as other bonds of
- 4 collectors of state taxes, and he shall execute to the State of Maryland a separate bond
- 5 in the penal sum of thirty thousand dollars (\$30,000.), with at least three (3) sureties
- 6 to be approved by the County Commissioners of Garret County, or fifteen thousand
- 7 dollars (\$15,000.), with corporate surety, with the condition that the above bounden
- 8 shall well and faithfully execute his office of [Treasurer] SUPERVISOR OF TAX
- 9 COLLECTION of Garrett County and shall account for and pay to the County
- 10 Commissioners of [said] THE county on their order the several sums of moneys which
- 11 he shall receive for [said] THE county, or be answerable for by law at such time and
- 12 in such manner as the law shall direct, then [said] THE obligation to be void,
- 13 otherwise to be and remain in full force and virtue in law, and [said] THE bond, when
- 14 approved, shall be recorded in the office of the Clerk of the Circuit Court for Garrett
- 15 County. He shall also secure and file collateral from such bank or banks as he may
- 16 use as depositories of tax funds in such amount or amounts as will be sufficient to
- 17 secure [said] THE deposits, which collateral shall be filed with the State Treasurer.
- 18 C. The County Commissioners of Garrett County shall levy a sufficient sum 19 to pay the premiums on all surety bonds given under this section.
- D. In the case of the [default] FAILURE of [the person so selected] AN
- 21 INDIVIDUAL APPOINTED TO THE OFFICE OF THE SUPERVISOR OF TAX COLLECTION to
- 22 qualify and execute the bonds hereinbefore required [before the expiration of twenty
- 23 (20) days next after the first day of January when his term of office should begin, or
- 24 in the event of the Treasurer's removal from the county or his removal from office or
- 25 his death or resignation during his term of office] OR THE OCCURRENCE OF A
- 26 VACANCY IN THE OFFICE OF SUPERVISOR OF TAX COLLECTION, the County
- 27 Commissioners shall at once proceed to fill such vacancy [by the election of a
- 28 competent person for the remainder of the term, who shall, within twenty (20) days
- 29 from the date of his election, qualify and bond as hereinbefore directed]. EACH
- 30 SUCCESSOR SUPERVISOR OF TAX COLLECTION SHALL BE SUBJECT TO THE
- 31 PROVISIONS OF THIS TITLE. The [County Commissioners shall continue after twenty
- 32 (20) days to make such election until a Treasurer shall qualify and bond as aforesaid,
- 33 provided that such new Treasurer] SUPERVISOR OF TAX COLLECTION so taking the
- 34 place made vacant by [removal] DISMISSAL, death or resignation shall not collect nor
- 35 take charge of any of the taxes that may be in the hands of [such late Treasurer] THE
- 36 PRIOR SUPERVISOR OF TAX COLLECTION uncollected and for which the bond of [such
- 37 late Treasurer] THE PRIOR SUPERVISOR OF TAX COLLECTION is responsible, except
- 38 as herein otherwise provided, but such taxes shall be collected under existing laws
- 39 applicable to collectors of state and county taxes when there is a death or resignation.
- 40 E. The sureties on any [Treasurer's] SUPERVISOR OF TAX COLLECTION'S
- 41 bonds shall, when so required by [said] THE COUNTY Commissioners, make oath in
- 42 due form of law, respectively, that they are the owners in their own right of real estate
- 43 situated in [said] THE county equal, at least, over and above their debts and
- 44 liabilities, in value to the amount of the bond.

- F. The Commissioners may at any time demand of any [Treasurer]
- 2 SUPERVISOR OF TAX COLLECTION such other or further bond, with such other or
- 3 further security, as in their judgment the interest of the state and county may
- 4 require.
- 5 110-5.
- 6 The County Commissioners shall provide and furnish the [Treasurer]
- 7 SUPERVISOR OF TAX COLLECTION an office in the Court House Building in the Town
- 8 of Oakland, which office shall be plainly designated by external signs as the office of
- 9 the [County Treasurer] SUPERVISOR OF TAX COLLECTION, and it shall be the duty of
- 10 the [Treasurer] SUPERVISOR OF TAX COLLECTION to keep [his said] THE office open
- 11 forty (40) hours each week and to attend therein for the transaction of business, by
- 12 person or by deputy, on every day of the week, except Saturday, Sunday and legal
- 13 holidays.
- 14 110-6.
- All taxes shall be levied for the fiscal year from July 1 to June 30 and as the first
- 16 day of January of such year as the date of finality. The County Commissioners shall
- 17 fix the rate of county taxation for such year on or before the 30th day of June. All
- 18 county taxes shall be due and payable on the first day of July and shall be overdue
- 19 and in arrears on the first day of the succeeding October, after which interest at the
- 20 rate of 1% per month shall be charged and collected. The [Treasurer] SUPERVISOR OF
- 21 TAX COLLECTION shall charge interest on the tax bills for county purposes regularly
- 22 in the manner aforesaid and shall note the same upon the [Treasurer's] COUNTY'S
- 23 books and upon the receipt given for taxes so paid.

- 25 It shall be the duty of the Clerk of said County Commissioners, within ten (10)
- 26 days after the annual tax levy shall have been made, to deliver to the Treasurer a fair
- 27 copy of the assessment lists of said county, showing the aggregate assessment of every
- 28 person, corporate institution or set of persons as the same then appears on the
- 29 assessment books of said county, with the names of said owners arranged according to
- 30 election districts and alphabetically for each district, and also to deliver to said
- 31 Treasurer a certified copy of the order or resolution of said Commissioners making
- 32 such tax levy.]

- 34 A. The [Treasurer] SUPERVISOR OF TAX COLLECTION shall, at the close of
- 35 each month, deposit, in a bank to be designated by the Comptroller of the Treasury of
- 36 Maryland, all state taxes and money due the state which may have come into the
- 37 custody of the [Treasurer] DIRECTOR OF FINANCE during the month to the credit of
- 38 the Comptroller of the State Treasury, and shall receive therefor from the bank a
- 39 certificate of deposit, which the [Treasurer] SUPERVISOR OF TAX COLLECTION shall
- 40 immediately forward to the Comptroller, showing the amount placed to the
- 41 Comptroller's credit. The [Treasurer] SUPERVISOR OF TAX COLLECTION shall deposit
- 42 TO THE CREDIT OF GARRETT COUNTY all money in the custody of the [Treasurer]

- 1 SUPERVISOR OF TAX COLLECTION that is received for county taxes and dues each day
- 2 in such bank as the [Treasurer] DIRECTOR OF FINANCE may see fit [to the credit of
- 3 the County Treasurer of Garrett County]. The money shall be drawn only by the
- 4 [Treasurer making such deposit] DIRECTOR OF FINANCE and only for claims which
- 5 may have been levied and ordered paid by the County Commissioners.
- 6 B. If sufficient taxes have not been collected to pay [such] ANY orders as
- 7 have been drawn against the levy, the County Commissioners are hereby authorized,
- 8 if necessary, to borrow, on the faith and credit of the county, after September 1 of each
- 9 year, a sum not to exceed the total uncollected taxes for the current year at the legal
- 10 rate of interest, the same to be repaid from current tax collections. If tax collections
- 11 shall prove insufficient to retire all of the indebtedness, the County Commissioners,
- 12 in the year next succeeding the filing of the final report of the [County Treasurer]
- 13 DIRECTOR OF FINANCE for the year in which such borrowing shall have taken place,
- 14 shall levy an amount as may be necessary to repay the balance.
- 15 110-22.
- 16 The provisions of the Code of Public General Laws of Maryland now in force or
- 17 hereafter enacted applicable to collectors of state and county taxes, except where the
- 18 same are repealed by or are inconsistent with the provisions of this chapter, shall be
- 19 held to apply to the [Treasurer] SUPERVISOR OF TAX COLLECTION of [said county]
- 20 GARRETT COUNTY, who, as to his powers, rights, duties and liabilities, both civil and
- 21 criminal, and those of his bond or bondsmen, shall be in all respects on a footing with
- 22 the state and county collectors, except as herein provided.
- 23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 24 July 1, 2001.
