3 FOR the purpose of requiring the County Commissioners of Somerset County to
4 appropriate to certain organized volunteer fire companies in the County certain
5 amounts for certain fiscal years; mandating that the required appropriations for
6 fiscal year 2005 shall remain in effect for subsequent fiscal years unless altered
7 by a future enactment; providing for an effective date; and generally relating to
8 organized volunteer fire companies in Somerset County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:
