SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 21

INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT PROVIDE 26 (1)27 HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS ON AN

21 (RR) THE PROVISIONS OF § 15-837 OF THE INSURANCE ARTICLE APPLY TO 22 HEALTH MAINTENANCE ORGANIZATIONS.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act applies to all 24 policies, contracts, and health benefit plans issued, delivered, or renewed in the State

25 on or after October 1, 2001.

26 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 27 October 1, 2001.
