BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 14 MARYLAND, That the Laws of Maryland read as follows: 15 **Article 27 - Crimes and Punishments** 16 40B. 17 (a) In this section the following words have the meanings indicated. 18 "Code grabbing device" means a device that is capable of receiving (1) 19 and recording the coded signal sent by the transmitter of an electronic security 20 system and playing back the signal to disarm the electronic security system. 21 "Electronic security system" includes: (2)22 (i) An electronic home security system;

A motor vehicle security alarm system;

An automatic garage door opener; [and]

2 (V) AN ELECTRONIC OR MAGNETIC THEFT DETECTION DEVICE

A home detention monitoring device; AND

- 2 (V) AN ELECTRONIC OR MAGNETIC THEFT DETECTION DEVICE 3 USED IN A RETAIL ESTABLISHMENT DESIGNED TO PREVENT THEFT.
- 4 (b) A person may not manufacture, sell, use, or possess a code grabbing device
- 5 with the intent for the code grabbing device to be used in the commission of a crime.
- 6 (C) A PERSON MAY NOT KNOWINGLY POSSESS WITH INTENT TO COMMIT 7 THEFT ANY LAMINATED OR COATED BAG, CLOTHING, OR DEVICE INTENDED TO
- 8 SHIELD MERCHANDISE FROM DETECTION BY AN ELECTRONIC SECURITY SYSTEM.
- 9 (D) A PERSON MAY NOT KNOWINGLY POSSESS A TOOL OR DEVICE DESIGNED
- 10 TO ALLOW OR CAPABLE OF ALLOWING THE DEACTIVATION OR REMOVAL FROM ANY
- 11 MERCHANDISE ANY ELECTRONIC SECURITY SYSTEM OR DEVICE USED AS PART OF
- 12 AN ELECTRONIC SECURITY SYSTEM WITH THE INTENT TO:

- 13 (1) USE THE TOOL OR DEVICE TO DEACTIVATE ANY ELECTRONIC 14 SECURITY SYSTEM; OR

- 23 October 1, 2001.
