SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

21 MARYLAND, That the Laws of Maryland read as follows:

Article 5 - Calvert County

- 2 [2-104.
- 3 The county commissioners shall hold a public meeting at the office of the Board
- 4 of County Commissioners of Calvert County every Tuesday beginning at 10 a.m.,
- 5 except that on the second Tuesday of every month they shall also hold an evening
- 6 meeting beginning at 8 p.m. If that day is a holiday, the meeting shall be held at the
- 7 nearest convenient time, which shall be determined by the commissioners.]

- 9 (A) THE BOARD OF COUNTY COMMISSIONERS SHALL MEET REGULARLY FOR
- 10 THE TRANSACTION OF COUNTY BUSINESS ON THE DAYS THE BOARD SETS BY
- 11 RESOLUTION AT A PUBLIC PLACE DESIGNATED FOR THE MEETINGS.
- 12 (B) THE RESOLUTION SETTING THE REGULAR MEETING DAYS OF THE BOARD 13 MAY PROVIDE FOR:
- 14 (1) THE HOLDING OF MEETINGS IN ADDITION TO THE REGULAR 15 MEETING; AND
- 16 (2) THE CANCELLATION OF MEETINGS BECAUSE OF ILLNESS,
- 17 VACATION, OR OTHER REASONABLE CAUSE.
- 18 (C) THE COUNTY BUSINESS MEETINGS CONDUCTED BY THE BOARD SHALL
- 19 COMPLY WITH THE OPEN MEETINGS ACT UNDER ARTICLE 25, § 5 OF THE CODE.
- 20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 21 October 1, 2001.
