A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County Department of Detention Facilities - Home Detention**
3 **and Farm Labor Programs**

4 FOR the purpose of requiring the Administrator of the Anne Arundel County
5 Department of Detention Facilities to establish and administer a home
6 detention program and adopt regulations for the program; restricting which
7 inmates may be eligible for the program; providing that the inmates who
8 participate in the program are responsible for certain expenses and may be
9 required to pay a fee in connection with the program; setting penalties for an
10 inmate's violation of a term or condition of the program; authorizing the
11 Administrator to limit the number of participants in the program; repealing
12 authorization for the Administrator to assign certain inmates to perform farm
13 labor under certain conditions; repealing funding provisions for a farm labor
14 program; and generally relating to the home detention program and farm labor
15 program administered by the Anne Arundel County Department of Detention
16 Facilities.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
23 MARYLAND, That the Laws of Maryland read as follows:

24 **Article - Correctional Services**

25 11-703.

26 (a) (1) In this section the following words have the meanings indicated.

27 (2) "Administrator" means the Administrator of the County's local
28 correctional facilities.

1 (3) "Participant" means a convicted individual who participates in a
2 program under this section.

3 (4) "Program" means, unless the context requires otherwise, a
4 rehabilitation, HOME DETENTION, or work program established and conducted under
5 this section.

6 (b) This section applies only in Anne Arundel County.

7 (c) (1) If a provision of subsections (a) through (e) of this section is
8 inconsistent with another provision in the Code, the provision of subsections (a)
9 through (e) of this section controls.

10 (2) The privileges and penalties set forth in subsection [(d)(1)(v)]
11 (E)(1)(V) and (vi) of this section are the exclusive privileges and penalties that relate to
12 the length of sentence of a participant in a program.

13 (3) While released from confinement under the terms of a program, a
14 participant is not an agent, employee, or servant of the county.

15 (D) (1) THE ADMINISTRATOR SHALL:

16 (I) ESTABLISH AND ADMINISTER A HOME DETENTION PROGRAM;
17 AND

18 (II) ADOPT REGULATIONS FOR THE PROGRAM.

19 (2) (I) WHEN AN INDIVIDUAL WHO IS CONVICTED OF A CRIME IS
20 SENTENCED OR AT ANY TIME DURING THE INDIVIDUAL'S CONFINEMENT AS AN
21 INMATE, A SENTENCING JUDGE MAY ALLOW THE INDIVIDUAL TO PARTICIPATE IN
22 THE HOME DETENTION PROGRAM.

23 (II) IN ADDITION TO PARTICIPATION AT THE RECOMMENDATION
24 OF THE SENTENCING JUDGE UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, AT
25 ANY TIME AFTER AN INMATE HAS SERVED NOT LESS THAN 25% OF THE INMATE'S
26 SENTENCE, THE ADMINISTRATOR MAY PLACE THE INMATE IN THE HOME
27 DETENTION PROGRAM UNLESS THE COURT HAS ORDERED OTHERWISE.

28 (3) SUBJECT TO PARAGRAPH (4) OF THIS SUBSECTION, AN INMATE IS
29 ELIGIBLE FOR THE HOME DETENTION PROGRAM IF THE INMATE:

30 (I) IS RECOMMENDED FOR THE PROGRAM BY THE SENTENCING
31 JUDGE OR PLACED IN THE PROGRAM BY THE ADMINISTRATOR UNDER PARAGRAPH
32 (2) OF THIS SUBSECTION; AND

33 (II) HAS NO OTHER CHARGES PENDING IN ANY JURISDICTION.

34 (4) AN INMATE IS NOT ELIGIBLE FOR THE HOME DETENTION PROGRAM
35 IF THE INMATE:

36 (I) IS SERVING A SENTENCE FOR A CRIME OF VIOLENCE; OR

- 1 (II) HAS BEEN FOUND GUILTY OF THE CRIME OF:
- 2 1. CHILD ABUSE UNDER ARTICLE 27, § 35C OF THE CODE; OR
- 3 2. ESCAPE UNDER ARTICLE 27, § 137 OF THE CODE.
- 4 (5) WHILE PARTICIPATING IN THE HOME DETENTION PROGRAM, AN
- 5 INMATE IS RESPONSIBLE FOR:
- 6 (I) THE COSTS OF THE INMATE'S MEDICAL CARE AND RELATED
- 7 EXPENSES; AND
- 8 (II) THE COSTS OF THE INMATE'S LODGING, FOOD, CLOTHING,
- 9 TRANSPORTATION, RESTITUTION, AND TAXES.
- 10 (6) UNLESS THE COURT HAS ORDERED OTHERWISE, THE
- 11 ADMINISTRATOR MAY:
- 12 (I) COLLECT A REASONABLE FEE FROM EACH INMATE
- 13 PARTICIPATING IN THE HOME DETENTION PROGRAM; OR
- 14 (II) WAIVE OR REDUCE THE FEE.
- 15 (7) THE ADMINISTRATOR MAY DETERMINE THE MAXIMUM NUMBER OF
- 16 PARTICIPANTS IN THE HOME DETENTION PROGRAM.
- 17 (8) AN INMATE WHO KNOWINGLY VIOLATES A TERM OR CONDITION OF
- 18 THE HOME DETENTION PROGRAM IS SUBJECT TO:
- 19 (I) THE PENALTIES PROVIDED UNDER § 11-726 OF THIS SUBTITLE;
- 20 AND
- 21 (II) ANY OTHER DISCIPLINARY ACTION AUTHORIZED UNDER LAW.
- 22 [(d)] (E) (1) The Administrator may:
- 23 (i) establish, for the rehabilitation and training of an inmate who
- 24 is sentenced to imprisonment in a local correctional facility, a program that enables
- 25 the inmate to:
- 26 1. attend a vocational or educational institution in the
- 27 county;
- 28 2. work at gainful, private employment in the county; or
- 29 3. participate in any other training or rehabilitation program
- 30 in the county;
- 31 (ii) establish eligibility criteria for participation in a program;

1 (iii) release an eligible inmate from actual confinement to
2 participate in a program;

3 (iv) establish any other training or rehabilitation program;

4 (v) reduce a participant's sentence 1 day for each day that the
5 participant:

6 1. performs with exceptional industry, application, and skill
7 any industrial, agricultural, or administrative task assigned to the participant; or

8 2. performs with satisfactory industry, application, and
9 progress in the program to which the participant is assigned; and

10 (vi) after an administrative hearing, cancel any earned diminution
11 of an inmate's term of confinement if the inmate violates a regulation adopted under
12 this section.

13 (2) (i) The Administrator shall adopt regulations to conduct each
14 program.

15 (ii) In adopting the regulations, the Administrator shall consider
16 the safety of the public and the security of a local correctional facility.

17 (iii) If a condition of sentence imposed by a court on an inmate is
18 inconsistent with a regulation adopted under this subsection, the condition imposed
19 by the court controls as to that inmate.

20 (3) While not released from confinement under the terms of a program,
21 each participant shall be confined in a local correctional facility.

22 (4) (i) The Administrator or Administrator's designee shall collect
23 each participant's total earnings, less payroll deductions.

24 (ii) From the participant's earnings, the Administrator or designee
25 shall pay:

26 1. the cost to the County of providing food, lodging, and
27 clothing for the participant;

28 2. the food, travel, and other expenses of the participant
29 incidental to participation in the program;

30 3. voluntary or court-ordered payments for support of a
31 dependent;

32 4. court-ordered costs and fines;

33 5. repayment to the State for court-appointed counsel;

1 (ii) the person requesting the farm labor shall pay the costs
2 incident to an assignment to farm labor, including the cost of transportation of the
3 inmates to and from the local correctional facility, a reasonable per diem wage for an
4 inmate performing farm labor, and the cost of properly guarding an inmate while
5 performing farm labor;

6 (iii) the Administrator may require proof of financial responsibility,
7 including a payment in advance;

8 (iv) the person requesting the farm labor shall assume any liability
9 for an injury to an inmate while being transported to or from a local correctional
10 facility or while performing farm labor;

11 (v) assignments to farm labor shall be made on a daily basis only
12 and an inmate assigned to farm labor shall be returned to the local correctional
13 facility each night; and

14 (vi) other terms and conditions that the Administrator considers
15 advisable.

16 (3) The County Council shall reimburse the Administrator out of the
17 County fund for any expenses incurred in conveying an inmate to and from a farm
18 labor site or in properly guarding an inmate while performing farm labor under
19 regulations that the Administrator or other officer considers necessary for the health
20 and safe custody of the inmate.]

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
22 October 1, 2001.
