(2) TO BE ADMITTED TO A KINDERGARTEN PROGRAM IN A PUBLIC 4 5 SCHOOL, AN INDIVIDUAL MUST BE AT LEAST 5 YEARS OF AGE ON OR BEFORE: NOVEMBER 30, IF THE INDIVIDUAL ENROLLS IN THE PROGRAM (I) 6 7 IN THE YEAR 2001: (II) OCTOBER 31, IF THE INDIVIDUAL ENROLLS IN THE PROGRAM IN 8 9 THE YEAR 2002; SEPTEMBER 30, IF THE INDIVIDUAL ENROLLS IN THE PROGRAM 10 (III) 11 IN THE YEAR 2003; OR 12 (IV) THE FIRST DAY OF THE SCHOOL YEAR IN WHICH THE 13 INDIVIDUAL ENROLLS, IF THE INDIVIDUAL ENROLLS IN THE YEAR 2004 OR ANY YEAR 14 THEREAFTER. 15 SECTION 2.
