A BILL ENTITLED

1 AN ACT concerning

2 Creation of a State Debt - Montgomery County - Round House Theatre

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$1,200,000,
- 4 the proceeds to be used as a grant to the Board of Directors of Round House
- 5 Theatre, Inc. for certain development or improvement purposes; providing for
- 6 disbursement of the loan proceeds, subject to a requirement that the grantee
- 7 provide and expend a matching fund; and providing generally for the issuance
- 8 and sale of bonds evidencing the loan.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 10 MARYLAND, That:
- 11 (1) The Board of Public Works may borrow money and incur indebtedness on
- 12 behalf of the State of Maryland through a State loan to be known as the Montgomery
- 13 County Round House Theatre Loan of 2001 in a total principal amount equal to the
- 14 lesser of (i) \$1,200,000 or (ii) the amount of the matching fund provided in accordance
- 15 with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and
- 16 delivery of State general obligation bonds authorized by a resolution of the Board of
- 17 Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 18 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 19 (2) The bonds to evidence this loan or installments of this loan may be sold as 20 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 21 § 8-122 of the State Finance and Procurement Article.
- 22 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 23 and first shall be applied to the payment of the expenses of issuing, selling, and
- 24 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 25 shall be credited on the books of the Comptroller and expended, on approval by the
- 26 Board of Public Works, for the following public purposes, including any applicable
- 27 architects' and engineers' fees: as a grant to the Board of Directors of Round House
- 28 Theatre, Inc. (referred to hereafter in this Act as "the grantee") for the design,
- 29 construction and capital equipping of the interior of 7501 Wisconsin Avenue in
- 30 Bethesda, including, but not limited to, construction and installation of a lighting and

- 1 sound system, stage, box office, concession area, and dressing area in order that the 2 facility can function as a performing arts theatre.
- 3 (4) An annual State tax is imposed on all assessable property in the State in
- 4 rate and amount sufficient to pay the principal of and interest on the bonds, as and 5 when due and until paid in full. The principal shall be discharged within 15 years
- 6 after the date of issuance of the bonds.
- 7 (5) Prior to the payment of any funds under the provisions of this Act for the
- 8 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 9 matching fund. No part of the grantee's matching fund may be provided, either
- 10 directly or indirectly, from funds of the State, whether appropriated or
- 11 unappropriated. No part of the fund may consist of real property or in kind
- 12 contributions. The fund may include funds expended prior to the effective date of this
- 13 Act. In case of any dispute as to the amount of the matching fund or what money or
- 14 assets may qualify as matching funds, the Board of Public Works shall determine the
- 15 matter and the Board's decision is final. The grantee has until June 1, 2003, to
- 16 present evidence satisfactory to the Board of Public Works that a matching fund will
- 17 be provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 18 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 19 equal to the amount of the matching fund shall be expended for the purposes provided
- 20 in this Act. Any amount of the loan in excess of the amount of the matching fund
- 21 certified by the Board of Public Works shall be canceled and be of no further effect.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 23 June 1, 2001.
