	(i) Establish and implement a system to comparatively evaluate the quality of care outcomes and performance measurements of health maintenance organization benefit plans and services on an objective basis; and
4	(ii) Annually publish the summary findings of the evaluation.
7 8	(2) The purpose of a comparable performance measurement system established under this subsection is to assist health maintenance organization benefit plans to improve the quality of care provided by establishing a common set of performance measurements and disseminating the findings of the performance measurements to health maintenance organizations and interested parties.
	(3) The system, where appropriate, shall solicit performance information from enrollees of health maintenance organizations, INCLUDING INFORMATION REGARDING <u>SATISFACTION WITH</u> BEHAVIORAL HEALTH SERVICES, <u>AS FEASIBLE</u> .
13 14	(4) (i) The Commission shall adopt regulations to establish the system of evaluation provided under this subsection.
17	(ii) Before adopting regulations to implement an evaluation system under this subsection, the Commission shall consider any recommendations of the quality of care subcommittee of the Group Health Association of America and the National Committee for Quality Assurance.
	(5) The Commission may contract with a private, nonprofit entity to implement the system required under this subsection provided that the entity is not an insurer.
22 23	(6) The annual evaluation summary required under paragraph (1) of this subsection shall:
24 25	(i) Include a summary of the Drug Formulary Accreditation Standards of the National Committee for Quality Assurance (NCQA); and
	(ii) Indicate whether the formulary development process of each health maintenance organization evaluated complies with the National Committee for Quality Assurance (NCQA) accreditation standards.

AND BE IT FURTHER ENACTED, That the implementation of this Act shall be contingent on an increase to \$10 million in the total allowable fees assessed in any fiscal year as provided by § 19-111 of the Health - General Article. If the limit on the total allowable fees is not increased, the Maryland Health Care Commission shall notify the Department of Legislative Services no later than June 1, 2001 at 90 State Circle, Annapolis, Maryland 21401.
