A BILL ENTITLED

1 AN ACT concerning

2 **Charles County - Board of Education - Salary Increases**

3 FOR the purpose of increasing by a certain amount the salaries of the Chairman, Vice  
4 Chairman and members of the Charles County Board of Education; and  
5 providing that this Act does not apply to the salary or compensation of the  
6 incumbent Chairman, Vice Chairman and members of the Charles County  
7 Board of Education.

8 BY repealing and reenacting, with amendments,  
9 Article - Education  
10 Section 3-503  
11 Annotated Code of Maryland  
12 (1999 Replacement Volume and 2000 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article - Education**

16 3-503.

17 (a) (1) The salary of the Chairman of the County Board is:

18 (i) [\$3,710 for the calendar year 1995; and

19 (ii)] \$3,820 for calendar years [1996, 1997, and 1998] 1999  
20 THROUGH 2002; AND

21 (II) \$5,000 PER YEAR BEGINNING JANUARY 1, 2003 AND FOR EACH  
22 SUBSEQUENT YEAR.

23 (2) The Chairman is entitled, for travel and other expenses, to[:

24 (i) In calendar years 1997 and 1998, \$800; and

1 (ii) In calendar year 1999, and in each subsequent year,] \$1,500 IN  
2 CALENDAR YEAR 1999 AND EACH SUBSEQUENT YEAR.

3 (b) (1) The salary of the Vice Chairman of the County Board is:

4 (i) [\$3,400 for the calendar year 1995; and

5 (ii)] \$3,500 for the calendar years [1996, 1997, and 1998] 1999  
6 THROUGH 2002; AND

7 (II) \$4,000 PER YEAR BEGINNING JANUARY 1, 2003 AND EACH  
8 SUBSEQUENT YEAR.

9 (2) The Vice Chairman is entitled to \$600 each year for travel and other  
10 expenses.

11 (c) (1) The salary of a member of the County Board is:

12 (i) [\$3,090 for the calendar year 1995; and

13 (ii)] \$3,185 for the calendar years [1996, 1997, and] 1998 THROUGH  
14 2002; AND

15 (II) \$4,000 PER YEAR BEGINNING JANUARY 1, 2003 AND EACH  
16 SUBSEQUENT YEAR.

17 (2) Each member is entitled to \$600 each year for travel and other  
18 expenses.

19 (d) Each salary provided under this section shall be paid on a quarterly basis.

20 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,  
21 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or  
22 apply to the salary or compensation of the Chairman, Vice Chairman, or members of  
23 the Charles County Board of Education, but the provisions of this Act concerning the  
24 salary or compensation of the Chairman, Vice Chairman, or members of the Charles  
25 County Board of Education shall take effect at the beginning of the next following  
26 term of office.

27 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
28 October 1, 2001.
