CHAPTER _____

1 AN ACT concerning

2 **Somerset County - Public Officials - Salaries**

3 FOR the purpose of raising the salary of the members and certain staff of the Board
4 of License Commissioners of Somerset County, the State's Attorney for Somerset
5 County, the County Treasurer of Somerset County, the Sheriff of Somerset
6 County, the judges of the Orphans' Court for Somerset County, and the County
7 Commissioners of Somerset County; providing that this Act does not apply to the
8 salary or compensation of the incumbent State's Attorney for Somerset County,
9 the incumbent County Treasurer of Somerset County, the incumbent Sheriff of
10 Somerset County, the incumbent judges of the Orphans' Court for Somerset
11 County, or the incumbent County Commissioners of Somerset County; and
12 generally relating to Somerset County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article 2B - Alcoholic Beverages**

24 (u) (1) In Somerset County each of the members of the Board, except the
 25 chairman, shall receive an annual salary of [~~\$1,800~~] \$2,000, and the chairman shall
 26 receive an annual salary of [~~\$2,000~~] \$2,500.

27 (2) The County Commissioners shall provide a sum sufficient to pay for
 28 the salaries of the members of the Board.

29 (3) The County Commissioners may provide a sum sufficient to pay for
 30 all expenses of the Board, including:

31 (i) Salaries of personnel other than members of the Board; and

32 (ii) Costs of printing, supplies, and other expenses related to the
 33 operation of the Board.

2 (u) (1) This subsection applies only in Somerset County.

3 (2) The Board:

4 (i) Shall appoint a clerk to the Board at an annual salary of
5 [\$1,800] \$2,500; and

6 (ii) May designate an attorney for the Board at an annual salary of
7 [\$2,400] \$3,000.

10 (t) In Somerset County, (1) the State's Attorney's salary is [\$79,200] \$91,100.

13 (r) The annual salary of the County Treasurer of Somerset County is
14 [\$38,500] \$44,300.

17 (u) (1) (i) The Sheriff of Somerset County shall receive a salary of not less
18 than [\$41,800] \$48,100 and no expense allowance.

19 **Article - Estates and Trusts**

21 (t) (1) Each judge of the Court for Somerset County shall receive [\$31] \$34
22 for every day's attendance upon the sessions of the Court.

23 (2) Each judge shall also receive an allowance for traveling expenses of
24 [\$30] \$33 for every day's attendance upon the sessions of the Court.

25 (3) Each judge may be excused with pay two times in a calendar year.

28 (b) Each Commissioner shall receive an annual salary of [\$5,500] \$6,000.

2 (a) The members of the County Roads Board shall each receive, in addition to
3 their compensation as County Commissioners, a salary of [~~\$5,500~~] \$6,000 annually as
4 a member of the County Roads Board.

5 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III,
6 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or
7 apply to the salary or compensation of the State's Attorney for Somerset County, the
8 County Treasurer of Somerset County, the Sheriff of Somerset County, the judges of
9 the Orphans' Court for Somerset County, or the County Commissioners of Somerset
10 County in office on the effective date of this Act, but the provisions of this Act
11 concerning the salary or compensation of the State's Attorney for Somerset County,
12 the County Treasurer of Somerset County, the Sheriff of Somerset County, the judges
13 of the Orphans' Court for Somerset County, and the County Commissioners of
14 Somerset County shall take effect at the beginning of the next following terms of
15 office.

16 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 July 1, 2001.
