## 2 Crimes - Animal Cruelty - Inspections of Circuses

- 3 FOR the purpose of allowing a county or local animal control board to inspect certain
- 4 circuses to determine whether animal cruelty or other mistreatment of animals
- 5 has occurred under certain circumstances; requiring certain circuses to permit
- 6 certain inspections under certain circumstances; requiring a county or local
- 7 animal control board to report certain findings or refusal to permit inspections
- 8 to the United States Department of Agriculture under certain circumstances;
- 9 defining a certain term; and generally relating to animal cruelty.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:

- 19 (A) IN THIS SECTION, "CIRCUS" MEANS A TRAVELING EXHIBITION WHICH
- 20 INCLUDES ANIMALS AND IS REQUIRED TO BE LICENSED BY THE UNITED STATES
- 21 DEPARTMENT OF AGRICULTURE.
- 22 (B) A COUNTY OR LOCAL ANIMAL CONTROL BOARD MAY INSPECT IN A
- 23 REASONABLE MANNER AND AT A REASONABLE TIME A CIRCUS TO DETERMINE
- 24 WHETHER ANY ANIMALS UNDER THE CONTROL OF THE CIRCUS ARE BEING
- 25 SUBJECTED TO CRUELTY UNDER § 59 OF THIS SUBHEADING OR ARE OTHERWISE
- 26 BEING MISTREATED.
- 27 (C) A CIRCUS SHALL ALLOW A COUNTY OR LOCAL ANIMAL CONTROL BOARD
- 28 TO INSPECT IN A REASONABLE MANNER AND AT A REASONABLE TIME ANY ANIMALS

- 1 UNDER ITS CONTROL TO DETERMINE WHETHER ANY ANIMALS UNDER THE CONTROL
- 2 OF THE CIRCUS ARE BEING SUBJECTED TO CRUELTY UNDER § 59 OF THIS
- 3 SUBHEADING OR ARE OTHERWISE BEING MISTREATED.
- 4 (D) A COUNTY OR LOCAL ANIMAL CONTROL BOARD SHALL REPORT TO THE
- 5 UNITED STATES DEPARTMENT OF AGRICULTURE:
- 6 (1) IF IT FINDS THAT ANY ANIMALS UNDER THE CONTROL OF A CIRCUS
- 7 HAVE BEEN THE SUBJECT OF CRUELTY UNDER § 59 OF THIS SUBHEADING OR HAVE
- 8 OTHERWISE BEEN MISTREATED; OR
- 9 (2) A REFUSAL ON THE PART OF A CIRCUS TO ALLOW AN INSPECTION 10 UNDER THIS SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 12 October 1, 2001.
