- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:

- 19 A CONTRACT FOR THE SALE OF REAL PROPERTY LOCATED IN AN AREA
- 20 DESIGNATED AS A HISTORIC DISTRICT BY THE HISTORIC PRESERVATION
- 21 COMMISSION OF MONTGOMERY COUNTY, TO A MEMBER OF THE PUBLIC WHO
- 22 INTENDS TO USE THE PROPERTY FOR EITHER RESIDENTIAL OR COMMERCIAL
- 23 PURPOSES, IS NOT ENFORCEABLE BY THE VENDOR UNLESS THE PURCHASER IS
- 24 GIVEN, ON OR BEFORE ENTERING INTO THE CONTRACT FOR THE SALE OF THE
- 25 PROPERTY OR WITHIN 20 CALENDAR DAYS AFTER ENTERING INTO THE CONTRACT,
- 26 THE FOLLOWING INFORMATION IN WRITING:

- 1 (1) NOTICE THAT THE PROPERTY IS LOCATED IN A HISTORIC DISTRICT, 2 AS DESIGNATED BY THE HISTORIC PRESERVATION COMMISSION OF MONTGOMERY 3 COUNTY;
- 4 (2) NOTICE THAT REGULATIONS, ORDINANCES, AND GUIDELINES
- 5 CONCERNING HISTORIC PRESERVATION ADOPTED BY THE HISTORIC PRESERVATION
- 6 COMMISSION OF MONTGOMERY COUNTY MUST BE FOLLOWED WHEN RENOVATIONS
- 7 OR OTHER CHANGES ARE MADE TO THE PROPERTY; AND
- 8 (3) THE ADDRESS AND TELEPHONE NUMBER OF THE HISTORIC
- 9 PRESERVATION COMMISSION OF MONTGOMERY COUNTY, TO ENABLE THE
- 10 PURCHASER TO REQUEST FURTHER INFORMATION ABOUT THE REGULATIONS,
- 11 ORDINANCES, AND GUIDELINES CONCERNING HISTORIC PRESERVATION THAT
- 12 APPLY TO THE PROPERTY PURCHASED OR TO BE PURCHASED.
- 13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 14 October 1, 2001.
