A BILL ENTITLED

1 AN ACT concerning

2 **Education - New Baltimore City Board of School Commissioners - Student**  
3 **Members**

4 FOR the purpose of authorizing a student member of the New Baltimore City Board  
5 of School Commissioners to have certain voting privileges; prohibiting a student  
6 member from attending certain sessions; and generally relating to student  
7 members of the New Baltimore City Board of School Commissioners.

8 BY repealing and reenacting, with amendments,  
9 Article - Education  
10 Section 3-108.1(c) and (o)  
11 Annotated Code of Maryland  
12 (1999 Replacement Volume and 2000 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article - Education**

16 3-108.1.

17 (c) The Board consists of:

18 (1) Nine voting members jointly appointed by the Mayor of Baltimore  
19 City and the Governor from a list of qualified individuals submitted to the Mayor and  
20 the Governor by the State Board; and

21 (2) One [nonvoting] VOTING student member appointed as provided in  
22 subsection (o) of this section.

23 (o) (1) One student member shall be a student enrolled in the Baltimore  
24 City Public School System who shall be selected by the Associated Student Congress  
25 of Baltimore City.

- 1           (2)     The term of a student member is 1 year.
- 2           (3)     A student member may not serve more than two consecutive full  
3 terms.
- 4           (4)     THE STUDENT MEMBER MAY VOTE ON ALL MATTERS BEFORE THE  
5 BOARD EXCEPT THOSE RELATING TO:
- 6                   (I)     PERSONNEL;
- 7                   (II)    CAPITAL AND OPERATING BUDGETS;
- 8                   (III)   SCHOOL CLOSINGS, REOPENINGS, AND BOUNDARIES;
- 9                   (IV)   COLLECTIVE BARGAINING DECISIONS;
- 10                  (V)     STUDENT DISCIPLINARY MATTERS; AND
- 11                  (VI)    APPEALS TO THE BOARD AS PROVIDED UNDER §§ 4-205 AND  
12 6-202 OF THIS ARTICLE.
- 13           (5)     THE STUDENT MEMBER MAY NOT ATTEND OR PARTICIPATE IN AN  
14 EXECUTIVE OR SPECIAL SESSION OF THE BOARD.
- 15     SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
16 October 1, 2001.
