BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That the Laws of Maryland read as follows: 17 **Article - Criminal Procedure** 18 13-105. Each application for the forfeiture of contraband shall be by 19 20 complaint AND SHALL BE FILED IN THE DISTRICT COURT OR CIRCUIT COURT OF THE 21 COUNTY IN WHICH THE CONTRABAND WAS SEIZED. 22 [A copy of the complaint and show cause order shall be served in 23 accordance with the Maryland Rules] THE COMPLAINT SHALL BE SERVED IN 24 ACCORDANCE WITH MARYLAND RULE 2-121 OR 3-121(A), OR IF SERVICE OF PROCESS 25 IS UNABLE TO BE MADE AND THE SUMMONS IS RETURNED NON EST, SUBSTITUTE 26 SERVICE MAY BE MADE IN ACCORDANCE WITH MARYLAND RULE 2-122 OR 3-121(B) OR

- 1 (b) (1) If a conviction, including a plea of guilty or plea of nolo contendere, is
- 2 entered against a person arrested in connection with the seizure of the money, the
- 3 financial authority shall apply to the District Court or circuit court for an order
- 4 forfeiting the money to the jurisdiction that the financial authority serves.
- 5 (2) The financial authority shall apply for the order within 90 days after 6 entry of the conviction or plea, unless the case is appealed.
- 7 (c) Before ordering a forfeiture of the money, the court must be satisfied that
- 8 no undetermined proceeding to recover the money is pending in court against the
- 9 financial authority.
- 10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 11 October 1, 2001.
