- 1 (C) THE TOTAL NUMBER OF ENROLLEES IN THE INSURANCE PLAN OFFERED 2 UNDER THE DEMONSTRATION PROJECT MAY NOT EXCEED 30,000 INDIVIDUALS.
- 3 (D) THE MARYLAND INSURANCE ADMINISTRATION SHALL ANNUALLY REVIEW
- 4 THE RECORDS OF THE DEMONSTRATION PROJECT AND THE INSURER CONTRACTED
- 5 TO PROVIDE BENEFITS UNDER THE DEMONSTRATION PROJECT TO ENSURE FISCAL
- 6 SOUNDNESS AND COMPLIANCE WITH:
- 7 (1) TITLE 4, SUBTITLE 3 OF THE INSURANCE ARTICLE;
- 8 (2) TITLE 5, SUBTITLES 1, 2, AND 9 OF THE INSURANCE ARTICLE; AND
- 9 (3) TITLE 9 OF THE INSURANCE ARTICLE.
- 10 (E) ON OR BEFORE SEPTEMBER 1 OF EACH YEAR AND SUBJECT TO § 2-1246 OF
- 11 THE STATE GOVERNMENT ARTICLE, THE FOUNDATION SHALL PROVIDE ANNUAL
- 12 REPORTS TO THE APPROPRIATE COMMITTEES OF THE MARYLAND GENERAL
- 13 ASSEMBLY ON THE SCOPE AND STATUS OF THE DEMONSTRATION PROJECT.
- 14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 15 July 1, 2001. It shall remain effective for a period of 42 months and, at the end of
- 16 December 31, 2005, with no further action required by the General Assembly, this Act
- 17 shall be abrogated and of no further force and effect.
