- 3 FOR the purpose of establishing a personal consumption import license to be issued
- by the Office of the Comptroller to certain individuals; authorizing a licensee to
- 5 accept delivery of certain wine; prohibiting a licensee from designating any
- 6 other person to accept delivery; specifying a certain license fee; requiring that an
- 7 applicant for a license and a licensee pay a certain tax; requiring the court to
- 8 impose certain penalties if an individual under a certain age is found to have
- 9 knowingly and willfully accepted delivery of wine under this Act; providing for
- the beginning date of a certain suspension of a driver's license; requiring the
- Office of the Comptroller to adopt certain regulations; providing for the
- termination of this Act; and generally relating to a personal consumption import
- license for certain wine.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:
- 22 Article 2B Alcoholic Beverages
- 23 TITLE 7.5. PERSONAL CONSUMPTION IMPORT LICENSE.
- 24 7.5-101.
- 25 (A) (1) THERE IS A PERSONAL CONSUMPTION IMPORT (PCI) LICENSE.
- 26 (2) THE PCI LICENSE IS TO BE ISSUED BY THE OFFICE OF THE
- 27 COMPTROLLER TO INDIVIDUALS WHO ARE 21 YEARS OF AGE OR OLDER
- 28 THROUGHOUT THE STATE IN ACCORDANCE WITH THIS SECTION.

- 1 (B) A PCI LICENSE ENTITLES THE LICENSEE TO RECEIVE DELIVERY OF A
- 2 MAXIMUM OF ONE CASE CONTAINING NOT MORE THAN 9 LITERS OF WINE PER
- 3 MONTH.
- 4 (C) A LICENSEE MAY NOT DESIGNATE ANY OTHER PERSON TO ACCEPT
- 5 DELIVERY OF WINE UNDER THIS SECTION.
- 6 (D) THE ANNUAL PCI LICENSE FEE IS \$100.
- 7 (E) AN APPLICANT FOR A PCI LICENSE SHALL PAY TO THE OFFICE OF THE 8 COMPTROLLER \$11.42 AS A STATE EXCISE TAX ON WINE.
- 9 (F) (1) IF AN INDIVIDUAL UNDER THE AGE OF 21 YEARS IS FOUND TO HAVE
- 10 KNOWINGLY AND WILLFULLY ACCEPTED DELIVERY OF WINE UNDER THIS SECTION,
- 11 THE COURT:
- 12 (I) SHALL REQUIRE THE INDIVIDUAL TO PERFORM 500 HOURS OF
- 13 COMMUNITY SERVICE; AND
- 14 (II) SHALL ORDER THE MOTOR VEHICLE ADMINISTRATION TO
- 15 BEGIN AN ACTION TO SUSPEND THE DRIVER'S LICENSE OF THE INDIVIDUAL.
- 16 (2) IF THE INDIVIDUAL SUBJECT TO A SUSPENSION UNDER THIS
- 17 SUBSECTION DOES NOT HOLD A LICENSE TO OPERATE A MOTOR VEHICLE ON THE
- 18 DATE OF THE DISPOSITION, THE SUSPENSION SHALL BEGIN:
- 19 (I) IF THE INDIVIDUAL IS AT LEAST 16 YEARS OF AGE ON THE DATE
- 20 OF THE DISPOSITION, ON THE DATE OF THE DISPOSITION; OR
- 21 (II) IF THE INDIVIDUAL IS YOUNGER THAN 16 YEARS OF AGE ON
- 22 THE DATE OF THE DISPOSITION, ON THE DATE THE INDIVIDUAL REACHES THE
- 23 INDIVIDUAL'S 16TH BIRTHDAY.
- 24 (G) THE OFFICE OF THE COMPTROLLER SHALL ADOPT REGULATIONS TO
- 25 CARRY OUT THIS SECTION.
- 26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 27 October 1, 2001. It shall remain effective for a period of 2 years and, at the end of
- 28 September 30, 2003, with no further action required by the General Assembly, this
- 29 Act shall be abrogated and of no further force and effect.
