1 AN ACT concerning

2 **Higher Education - Edward T. Conroy Memorial Scholarship Program -**
3 **Eligibility**

4 FOR the purpose of expanding the eligibility for the Edward T. Conroy Memorial
5 Scholarship Program to include certain veterans; limiting the number of
6 veterans' scholarships under the Program that the State Scholarship
7 Administration may award annually; and generally relating to eligibility for the
8 Edward T. Conroy Memorial Scholarship Program.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article - Education**

17 18-601.

18 (a) (1) In this section the following words have the meanings indicated.

19 (2) "Disabled public safety employee" means a State or local public safety
20 employee who sustains an injury in the line of duty that:

1 (i) Precludes the individual from continuing to serve or be
2 employed as a State or local public safety employee; and

3 (ii) In the case of a volunteer member of a fire department or
4 ambulance or rescue company or squad, precludes the member from continuing to be
5 employed in the nonpublic safety occupation in which the member is engaged at the
6 time of the injury.

7 (3) "Surviving spouse" means a person who has not remarried.

8 (4) "State or local public safety employee" means a person who is:

9 (i) A career or volunteer member of a:

10 1. Fire department;

11 2. Ambulance company or squad; or

12 3. Rescue company or squad;

13 (ii) A law enforcement officer;

14 (iii) A correctional officer; or

15 (iv) A member of the Maryland National Guard who was a resident
16 of this State at the time of death.

17 (b) There is a program of scholarships that are awarded under this section.

18 (c) The Program is the Edward T. Conroy Memorial Scholarship Program.

19 (d) A person may apply to the Administration for a scholarship under this
20 section if the person:

21 (1) Is a resident of Maryland;

22 (2) (i) Is accepted for admission or enrolled in the regular
23 undergraduate, graduate or professional program at an eligible institution; or

24 (ii) Is enrolled in a 2-year terminal certificate program in which
25 the course work is acceptable for transfer credit for an accredited baccalaureate
26 program in an eligible institution; and

27 (3) Is at least 16 years old and a son or daughter of a member of the
28 armed forces who was a resident of this State at the time the parent:

29 (i) Died or was totally and permanently disabled as a result of
30 military service after December 7, 1941; or

1 (ii) Was declared to be a prisoner of war or missing in action, if that
2 occurred on or after January 1, 1960 as a result of the Vietnam conflict, and if the
3 child was born prior to or while the parent was a prisoner of war or missing in action;

4 (4) Was a prisoner of war on or after January 1, 1960 as a result of the
5 Vietnam conflict and was a resident of this State at the time the person was declared
6 to be a prisoner of war or missing in action;

7 (5) (i) Is at least 16 years old and a son or daughter of any State or
8 local public safety employee killed in the line of duty; or

9 (ii) Is the surviving spouse of any State or local public safety
10 employee killed in the line of duty; [or]

11 (6) Is a disabled public safety employee; OR

12 (7) IS A VETERAN, AS DEFINED UNDER § 9-901 OF THE STATE
13 GOVERNMENT ARTICLE, WHO:

14 (I) SUFFERS A SERVICE-RELATED DISABILITY OF 50% OR
15 GREATER; AND

16 (II) HAS EXHAUSTED OR IS NO LONGER ELIGIBLE FOR FEDERAL
17 VETERANS' EDUCATIONAL BENEFITS.

18 (e) A scholarship awarded under this section:

19 (1) May be used for the tuition and mandatory fees at any eligible
20 institution; and

21 (2) May not:

22 (i) Exceed the equivalent annual tuition and mandatory fees of a
23 resident undergraduate student at the University of Maryland, College Park; and

24 (ii) Be less than the lesser of:

25 1. \$3,000; or

26 2. The equivalent annual tuition and mandatory fees of a
27 resident of the institution attended by the recipient of the scholarship.

28 (f) (1) Each recipient of a scholarship under this section may hold the award
29 for 5 years of full-time study or 8 years of part-time study.

30 (2) THE ADMINISTRATION MAY NOT AWARD MORE THAN 15
31 SCHOLARSHIPS ANNUALLY UNDER SUBSECTION (D)(7) OF THIS SECTION.

32 (g) The Commission:

1 (1) May accept any gift or grant from any person for the Edward T.
2 Conroy Scholarship Fund;

3 (2) Shall use any gift or grant that it receives for a scholarship from the
4 Program; and

5 (3) Shall deposit any gift or grant that it receives for the Program with
6 the State Treasurer in a nonbudgeted account.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 July 1, 2001.
