- 8 relating to a violation of speed limitations; authorizing the inspection of certain
- 9 records by employees or agents of a certain party that has entered into an
- agreement with the Maryland Transportation Authority to use a certain toll
- 11 collection system for certain applications for certain purposes; authorizing the
- 12 inspection of certain records by employees or agents of certain entities operating

# 2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF3 MARYLAND, That the Laws of Maryland read as follows:

#### Article - State Government

6 (a) Unless otherwise provided by law, a custodian shall deny inspection of a 7 public record, as provided in this section.

8 (m) (1) Subject to the provisions of paragraph (2) of this subsection, a

9 custodian shall deny inspection of all photographs, videotapes or electronically

10 recorded images of vehicles, vehicle movement records, personal financial

11 information, credit reports, or other personal or financial data created, recorded,

12 obtained by or submitted to the Maryland Transportation Authority or its agents or

13 employees in connection with any electronic toll collection system OR ASSOCIATED14 TRANSACTION SYSTEM.

15 (2) A custodian shall permit inspection of the records enumerated in 16 paragraph (1) of this subsection by:

an individual named in the record;

18 (ii) the attorney of record of an individual named in the record; [or]

19(iii)employees or agents of the Maryland Transportation Authority20in any investigation or proceeding relating to A VIOLATION OF SPEED LIMITATIONS21OR TO the imposition of or indemnification from liability for failure to pay a toll in

(IV) EMPLOYEES OR AGENTS OF A THIRD PARTY THAT HAS
ENTERED INTO AN AGREEMENT WITH THE MARYLAND TRANSPORTATION
AUTHORITY TO USE AN ELECTRONIC TOLL COLLECTION SYSTEM FOR NONTOLL
APPLICATIONS IN THE COLLECTION OF REVENUES DUE TO THE THIRD PARTY; OR

27 (V) EMPLOYEES OR AGENTS OF AN ENTITY IN ANOTHER STATE
 28 OPERATING OR HAVING JURISDICTION OVER A TOLL FACILITY.

(R) EXCEPT TO THE PERSON IN INTEREST, A CUSTODIAN SHALL DENY
INSPECTION OF ALL RECORDS OF PERSONS OR VEHICLES CREATED, GENERATED,
OBTAINED BY, OR SUBMITTED TO THE MASS TRANSIT ADMINISTRATION, ITS AGENTS,
OR EMPLOYEES IN CONNECTION WITH THE USE OR PURCHASE OF ANY GOODS OR
SERVICES PROVIDED BY THE MASS TRANSIT ADMINISTRATION, ITS AGENTS,
EMPLOYEES, OR CONTRACTORS.

35 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 36 October 1, 2001.
