A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County - Property Tax Credit - George Washington House**
3 **PG 401-01**

4 FOR the purpose of authorizing the governing body of Prince George's County to
5 grant a property tax credit against the county property tax or special district tax
6 imposed on certain property owned by the Aman Memorial Trust and known as
7 the George Washington House; and generally relating to property tax credits in
8 Prince George's County.

9 BY repealing and reenacting, with amendments,

13 (1994 Replacement Volume and 2000 Supplement)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article - Tax - Property**

17 9-318.

18 (c) The governing body of Prince George's County may grant, by law, a
19 property tax credit under this section against the county property tax or special
20 district tax imposed on:

21 (1) property that is owned by the Chapel Hill Citizens' Association;

22 (2) property that is:

23 (i) owned by the Clinton Boys and Girls Club; and

24 (ii) used only for nonprofit athletic recreation;

25 (3) property that is owned by the East Pines Citizens' Association;

- 1 (4) property that is owned by the Lions Club of Bowie;
- 2 (5) property that is owned by the Prince George's Jaycees, Incorporated;
- 3 (6) property that is owned by the Suitland Civic Association,
4 Incorporated;
- 5 (7) real property that is:
- 6 (i) owned by the Prince George's County Parks and Recreation
7 Foundation; and
- 8 (ii) is not used for a commercial purpose;
- 9 (8) property that is:
- 10 (i) owned by the Freestate Riding Club, Inc.; and
- 11 (ii) used only for nonprofit athletic recreation;
- 12 (9) property that is owned by a boys and girls club in Prince George's
13 County that is chartered by the Prince George's County Boys and Girls Club,
14 Incorporated; [and]
- 15 (10) property that is owned by the Lake Arbor Foundation, Incorporated;
16 AND
- 17 (11) PROPERTY THAT IS:
- 18 (I) OWNED BY THE AMAN MEMORIAL TRUST; AND
- 19 (II) KNOWN AS THE GEORGE WASHINGTON HOUSE.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 July 1, 2001.
