18 (a) In this subtitle, "elected member" means one of the nine elected members19 of the Prince George's County Board or a member appointed to fill a vacancy of one of20 these nine members.

21 (b) (1) The Prince George's County Board consists of nine elected members 22 and one student member selected under subsection (f)(2) of this section.

(2) FIVE OF THE NINE ELECTED MEMBERS SHALL BE ELECTED BASED
ON THE SCHOOL BOARD DISTRICT THEY REPRESENT, WITH ONE MEMBER ELECTED
FROM EACH DISTRICT.

(3) FOUR OF THE NINE ELECTED MEMBERS SHALL BE ELECTED AT
LARGE. THE FOUR CANDIDATES RECEIVING THE FIRST, SECOND, THIRD, AND

 (e) (1) If a candidate for the County Board dies or withdraws the candidacy during the period beginning with the date of the primary and ending 70 days before the date of the general election, the Board of Supervisors of Elections shall:
 (i) Replace the name of the deceased or withdrawn candidate on the ballot for the general election with the name of the candidate who received the next highest number of votes in the primary election; or

 (2) (i) Except as otherwise provided in subparagraph (ii) of this paragraph, the Board of Supervisors of Elections shall add to the ballot for the general election the name of any person who files as a candidate in accordance with paragraph (1)(ii) of this subsection.

1 (2) An eligible student shall file a nomination form at least 2 weeks

2 before a special election meeting of the Prince George's regional association of student

3 governments. Nomination forms shall be made available in the administrative offices

4 of all public senior high schools in the County, the office of student concerns, and the

5 office of the president of the regional association. The delegates to the regional

6 association annually shall elect the student member to the Board at a special election

7 meeting to be held each school year.

to hearings on appeals of special education placements, hearings held under §
6-202(a) of this article, or collective bargaining.

25(6)The Prince George's regional association of student governments may26establish procedures for the election of the student member of the County Board.

27 (7) The election procedures established by the Prince George's regional
28 association of student governments are subject to the approval of the elected members

11 [(h) (1) The County Board members from school board districts II, V, and 12 VIII who were elected for the first time at the November 6, 1973 election serve until 13 the first Monday in December 1978 and may seek reelection in 1978 for a 4-year 14 term.				
15 (2) The members from school board districts III, VI, and IX who were 16 elected at the November 6, 1973 election serve until the first Monday in December, 17 1980 and may seek reelection in 1980 for a 4-year term.]				
18 [(i)] (H) (1) With the approval of the Governor, the State Board may remove 19 a member of the County Board for any of the following reasons:

 (2) Before removing a member, the State Board shall send the member a copy of the charges pending and give the member an opportunity within 10 days to request a hearing. 				
27 (3) If the member requests a hearing within the 10-day period:				
 (i) The State Board promptly shall hold a hearing, but a hearing may not be set within 10 days after the State Board sends the member a notice of the hearing; and 				
 31 (ii) The member shall have an opportunity to be heard publicly 32 before the State Board in the member's own defense, in person or by counsel. 				
 33 (4) A member removed under this subsection has the right to a de novo 34 review of the removal by the Circuit Court for Prince George's County.

3 date of this Act shall terminate on the first Monday after the November 2002 election.

4 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 June 1, 2002.
