A BILL ENTITLED

1 AN ACT concerning

2 **Prince George's County - Assistant Sheriffs - Salaries**  
3 **PG 308-01**

4 FOR the purpose of altering the salary of the chief assistant sheriff and an assistant  
5 sheriff for Prince George's County to reflect a commissioned deputy sheriff  
6 appointed to the position of chief assistant sheriff or serving as an assistant  
7 sheriff for Prince George's County; requiring the Sheriff of Prince George's  
8 County to provide in the county budget for the salary of a commissioned deputy  
9 sheriff appointed to the position of chief assistant sheriff or serving as an  
10 assistant sheriff; and generally relating to the salary of the chief assistant  
11 sheriff and assistant sheriffs for Prince George's County.

12 BY repealing and reenacting, with amendments,

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
23 MARYLAND, That the Laws of Maryland read as follows:

24 **Article - Courts and Judicial Proceedings**

25 2-309.

26 (r) (2) (v) [The] EXCEPT AS PROVIDED IN SUBPARAGRAPH (VI) OF THIS  
27 PARAGRAPH, THE chief assistant sheriff shall receive an annual salary of \$65,728.

1 (VI) THE SALARY OF A COMMISSIONED DEPUTY SHERIFF  
2 APPOINTED TO THE POSITION OF CHIEF ASSISTANT SHERIFF SHALL BE PROVIDED  
3 FOR BY THE SHERIFF IN THE BUDGET OF THE COUNTY.

4 [(vi)] (VII) The Sheriff and the assistant sheriffs shall be provided  
5 with an annual clothing allowance equal to that which is provided to deputy sheriffs  
6 of all ranks for the procurement, care, and upkeep of clothing and leather goods, and  
7 administered for that purpose.

8 [(vii)] (VIII) 1. Except as provided in sub-subparagraph 2 of this  
9 subparagraph, the Sheriff, chief assistant sheriff, and assistant sheriffs shall receive  
10 each benefit, other than salary increases, that is negotiated for the deputy sheriffs by  
11 the Deputy Sheriffs' Association and granted to the management team of the Prince  
12 George's County Sheriff's office.

13 2. Any additional or increased benefit does not apply to the  
14 incumbent Sheriff, but shall take effect at the beginning of the next following term of  
15 office.

16 (6) (i) With the exception of the assistant sheriffs, all commissioned  
17 full-time employees, including deputy sheriffs of all ranks, that are provided for by  
18 the Sheriff in the budget of the County, shall be subject to the County personnel law.

19 (ii) [The] EXCEPT AS PROVIDED IN SUBPARAGRAPH (III) OF THIS  
20 PARAGRAPH, THE assistant sheriffs shall receive an annual salary of \$64,615.

21 (III) THE SALARY OF COMMISSIONED DEPUTY SHERIFFS SERVING  
22 AS ASSISTANT SHERIFFS SHALL BE PROVIDED FOR BY THE SHERIFF IN THE BUDGET  
23 OF THE COUNTY.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
25 October 1, 2001.
