SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

23 MARYLAND, That the Laws of Maryland read as follows:

1 **Article - Courts and Judicial Proceedings** 2 2-309. [The] EXCEPT AS PROVIDED IN SUBPARAGRAPH (VI) OF THIS 3 (r) (2) (v) 4 PARAGRAPH, THE chief assistant sheriff shall receive an annual salary of \$65,728. 5 THE SALARY OF A COMMISSIONED DEPUTY SHERIFF (VI) 6 APPOINTED TO THE POSITION OF CHIEF ASSISTANT SHERIFF SHALL BE PROVIDED 7 FOR BY THE SHERIFF IN THE BUDGET OF THE COUNTY. 8 (VII) The Sheriff and the assistant sheriffs shall be provided [(vi)]9 with an annual clothing allowance equal to that which is provided to deputy sheriffs 10 of all ranks for the procurement, care, and upkeep of clothing and leather goods, and 11 administered for that purpose. 12 [(vii)] (VIII) 1. Except as provided in sub-subparagraph 2 of this 13 subparagraph, the Sheriff, chief assistant sheriff, and assistant sheriffs shall receive 14 each benefit, other than salary increases, that is negotiated for the deputy sheriffs by 15 the Deputy Sheriffs' Association and granted to the management team of the Prince 16 George's County Sheriff's office. 17 2. Any additional or increased benefit does not apply to the 18 incumbent Sheriff, but shall take effect at the beginning of the next following term of 19 office. 20 (i) With the exception of the assistant sheriffs, all commissioned 21 full-time employees, including deputy sheriffs of all ranks, that are provided for by 22 the Sheriff in the budget of the County, shall be subject to the County personnel law. [The] EXCEPT AS PROVIDED IN SUBPARAGRAPH (III) OF THIS 23 (ii) 24 PARAGRAPH, THE assistant sheriffs shall receive an annual salary of \$64,615. 25 THE SALARY OF COMMISSIONED DEPUTY SHERIFFS SERVING (III)26 AS ASSISTANT SHERIFFS SHALL BE PROVIDED FOR BY THE SHERIFF IN THE BUDGET OF THE COUNTY. SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
