- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 21 MARYLAND, That the Laws of Maryland read as follows:

- 4 Assistance Fund, Inc. shall be paid over to the Maryland Standardbred Horsemen's
- 5 Assistance Fund, Inc. and the Maryland Thoroughbred Horsemen's Assistance Fund,
- 6 Inc., respectively.
- 7 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 8 October 1, 2001.
