1 AN ACT concerning

2 City of Annapolis - Alcoholic Beverages - Wine Festival License

- 3 FOR the purpose of authorizing in the City of Annapolis the Alcoholic Beverage
- 4 Control Board to issue a special festival (AWF) license for wine festivals;
- 5 establishing certain requirements for license applicants and for holders of
- 6 special festival licenses; establishing the scope of the license; placing certain
- 7 restrictions on the way wine is sold and displayed; establishing a certain license
- 8 fee; establishing the time, location, and primary purpose for wine festivals;
- 9 defining a certain term; and generally relating to wine festivals in the City of
- 10 Annapolis.

- 12 Article 2B Alcoholic Beverages

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:

18 Article 2B - Alcoholic Beverages

- 20 (A) IN THIS SECTION, "FESTIVAL" MEANS THE CITY OF ANNAPOLIS WINE
- 21 FESTIVAL.
- 22 (B) THIS SECTION APPLIES ONLY IN THE CITY OF ANNAPOLIS.
- 23 (C) THE ALCOHOLIC BEVERAGE CONTROL BOARD MAY ISSUE A SPECIAL
- 24 FESTIVAL (AWF) LICENSE.
- 25 (D) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE, AN
- 26 APPLICANT FOR A SPECIAL FESTIVAL LICENSE SHALL BE A HOLDER OF AN EXISTING
- 27 STATE CLASS 3 WINERY LICENSE OR STATE CLASS 4 LIMITED WINERY LICENSE
- 28 ISSUED UNDER THIS ARTICLE.

- 1 (E) A SPECIAL FESTIVAL LICENSEE SHALL DISPLAY AND SELL WINE THAT IS:
- 2 MANUFACTURED AND PROCESSED IN ANY STATE; AND (1)
- 3 (2) OFFERED AT RETAIL FOR CONSUMPTION ON OR OFF THE LICENSED 4 PREMISES ON THE DAYS AND FOR THE HOURS DESIGNATED FOR THE FESTIVAL.
- THIS SECTION DOES NOT PROHIBIT THE HOLDER OF A SPECIAL FESTIVAL 5 (F)
- 6 LICENSE FROM HOLDING ANOTHER ALCOHOLIC BEVERAGES LICENSE OF A
- 7 DIFFERENT CLASS OR NATURE.
- 8 THE LICENSE FEE IS \$50. (G)
- 9 (H) THE ALCOHOLIC BEVERAGE CONTROL BOARD:
- (1) MAY SELECT ONE WEEKEND ANNUALLY DURING JULY, AUGUST, OR 11 SEPTEMBER FOR THE FESTIVAL;
- SHALL CHOOSE A LOCATION IN THE CITY OF ANNAPOLIS FOR THIS 12 (2)
- 13 FESTIVAL THAT IS NOT LICENSED UNDER THIS ARTICLE; AND
- SHALL ASSURE THAT THE PRIMARY FOCUS OF THE FESTIVAL IS THE (3)
- 15 PROMOTION OF MARYLAND WINE.
- THE ALCOHOLIC BEVERAGE CONTROL BOARD SHALL ADOPT 16
- 17 REGULATIONS FOR CARRYING OUT THIS SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18
- 19 October 1, 2001.
