SECTION 3. AND BE IT FURTHER ENACTED, That the terms of the
4 appointed members of the Worcester County Board of Education serving on June 30,
5 2001 shall terminate as follows:

6 (a) The terms of appointed members which were scheduled to expire on June 7 30, 2003 shall terminate at the end of December 31, 2002; and

AND BE IT FURTHER ENACTED, That Sections 1 and 3 of this 23 Act shall take effect July 1, 2001, contingent on the taking effect of a redistricting 24 plan for the Worcester County Commissioner districts that provides for seven county 25 commissioner districts. If a redistricting plan for the seven commissioner districts for 26 Worcester County takes effect after July 1, 2001, but before the filing deadline for 27 candidates to file for election as Worcester County Commissioners in the November 28 2002 general election, Sections 1 and 3 shall take effect on the date that the 29 redistricting plan takes effect. If a redistricting plan for the seven commissioner 30 districts for Worcester County Commissioners does not take effect by the filing 31 deadline for candidates to file for election as Worcester County Commissioners in the 32 November 2002 general election, Sections 1 and 3 of this Act shall be null and void 33 without the necessity of further action by the General Assembly. On or before the 34 filing deadline for candidates to file for election as Worcester County Commissioners 35 in the November 2002 general election, the Worcester County Commissioners shall 36 certify to the Department of Legislative Services whether a redistricting plan for the 37 Worcester County Commissioner districts that provides for seven commissioner 38 districts took effect before the filing deadline, and, if so, on what date the redistricting 39 plan took effect.

- 1 SECTION 7. AND BE IT FURTHER ENACTED, That Sections 2 and 4 of this
- 2 Act shall take effect on the failure of Sections 1 and 3 to take effect as provided in

- 4 Act shall be null and void without the necessity of further action by the General
