BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 14 MARYLAND, That the Laws of Maryland read as follows: Chapter 292 of the Acts of 1999 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 17 MARYLAND, That: 18 Prior to the payment of any funds under the provisions of this Act for the (5)

19 purposes set forth in Section 1(3) above, the grantee shall provide and expend a 20 matching fund. No part of the grantee's matching fund may be provided, either

21 directly or indirectly, from funds of the State, whether appropriated or

- 1 unappropriated. No part of the fund may consist of real property, in kind
- 2 contributions, or funds expended prior the effective date of this Act. In case of any
- 3 dispute as to the amount of the matching fund or what money or assets may qualify
- 4 as matching funds, the Board of Public Works shall determine the matter and the
- 5 Board's decision is final. The grantee has until June 1, [2001] 2003, to present
- 6 evidence satisfactory to the Board of Public Works that a matching fund will be
- 7 provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 8 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 9 equal to the amount of the matching fund shall be expended for the purposes provided
- 10 in this Act. Any amount of the loan in excess of the amount of the matching fund
- 11 certified by the Board of Public Works shall be canceled and be of no further effect.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 June 1, 2001.
