1 A House Joint Resolution concerning	

- 1 A House Joint Resolution concerning
- 2 Patuxent River Watershed Amendment of Policy Plan
- 3 FOR the purpose of approving a certain amendment to the Patuxent River Policy
- 4 Plan; providing for a certain effective date; resolving that a copy of this
- 5 resolution be forwarded by the Department of Legislative Services to certain
- 6 individuals; and generally relating to the amendment of the Patuxent River
- 7 Policy Plan.
- 8 WHEREAS, § 5-812 of the State Finance and Procurement Article establishes
- 9 the Patuxent River Commission (the Commission); and
- WHEREAS, The Commission, the local governments represented on the
- 11 Commission, and the Maryland General Assembly adopted the original Patuxent
- 12 River Policy Plan (the Plan) in 1984 in order to serve as a policy guide for the
- 13 Commission, State agencies, and local governments in carrying out programs in the
- 14 Patuxent River watershed; and
- WHEREAS, §§ 5-805 and 5-806 of the State Finance and Procurement Article
- 16 provide that the Commission and the State Department of Planning shall periodically
- 17 review and evaluate pertinent information, trends, and issues regarding the Patuxent
- 18 River watershed in light of the Plan and the Commission's activities; and
- 19 WHEREAS, §§ 5-805 and 5-806 of the State Finance and Procurement Article
- 20 also provide procedures for updating the Plan through an amendment process; and
- 21 WHEREAS, Review and evaluation by the Commission have determined that
- 22 development within the Patuxent River watershed has expanded significantly since
- 23 1984, and this expanded development has resulted in the loss of forest cover,
- 24 agricultural land, open space, and wildlife habitat with a corresponding increase in

- 1 impervious surface area, thus elevating the level of nutrient and sediment pollution
- 2 in the Patuxent River; and
- 3 WHEREAS, Drawing on the outcome of several relevant Patuxent River studies
- 4 and projects, including "The Patuxent Watershed Demonstration Project", the
- 5 Commission addressed these issues and the management of the watershed in a draft
- 6 addendum to the Plan; and
- WHEREAS, In November 1997, the Commission adopted an addendum, known
- 8 as the 1997 Addendum, as an amendment to the 1984 Plan, and this was done for the
- 9 purpose of updating the Plan; and
- 10 WHEREAS, Effective October 24, 2000, all local governments represented on
- 11 the Commission adopted by resolution the 1997 Addendum; and
- WHEREAS, § 5-805 of the State Finance and Procurement Article provides
- 13 that, on approval by resolution of an amendment by at least six of the eight local
- 14 jurisdictions represented on the Commission, the amendment shall be presented to
- 15 the General Assembly for approval; and
- WHEREAS, The Patuxent River Policy Plan Amendment has been approved by
- 17 these local jurisdictions, and the General Assembly also finds itself in agreement with
- 18 the Plan Amendment; and
- 19 WHEREAS, Upon approval by the General Assembly, this Amendment to the
- 20 Plan is to serve as a policy guide for the Commission, State agencies, and local
- 21 governments in enhancing restoration and protection of the Patuxent River
- 22 watershed; and
- 23 WHEREAS, Under § 5-805(d)(2) of the State Finance and Procurement Article,
- 24 the effective date of an amendment is immediate upon approval by joint resolution of
- 25 the General Assembly, unless otherwise provided in the amendment, and there being
- 26 no other provision in this amendment, the effective date of this amendment is to be
- 27 immediate upon approval by the General Assembly of this Joint Resolution; now,
- 28 therefore, be it
- 29 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That, effective
- 30 immediately upon approval of this Joint Resolution, the General Assembly hereby
- 31 approves the 1997 Addendum as an amendment to the Patuxent River Policy Plan;
- 32 and be it further
- 33 RESOLVED, That a copy of this Resolution be forwarded by the Department of
- 34 Legislative Services to the Honorable Parris N. Glendening, Governor of Maryland;
- 35 the Honorable Thomas V. Mike Miller, Jr., President of the Senate of Maryland; the
- 36 Honorable Casper R. Taylor, Jr., Speaker of the House of Delegates; the Honorable
- 37 Harriet Tregoning, Secretary of the Department of Planning; and the Honorable Mary
- 38 C. Lorsung, Chair of the Patuxent River Commission.
