- 3 FOR the purpose of authorizing the Department of the Environment to impose
- 4 certain administrative penalties on certain suppliers of water serving certain
- 5 <u>numbers of people</u> for certain violations related to safe drinking water, <u>after</u>
- 6 <u>considering certain factors</u>; and generally relating to public water systems and
- 7 drinking water standards and requirements.

- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:

15 Article - Environment

16 9-413.

17 (a) A person who willfully violates § 9-412(a)(4) or (5) of this subtitle is subject

18 to a civil penalty of up to \$5,000 for each day on which the violation exists.

	(b) A person who violates § 9-412(a)(1), (2), or (3) of this subtitle is guilty of a misdemeanor and on conviction is subject to a fine not exceeding \$5,000 for each day on which the violation occurs or failure to comply continues.
6	(c) In an action brought in the appropriate court to enforce the order, a person who willfully violates or fails or refuses to comply with any order issued by the Secretary under this subtitle may be fined not more than \$5,000 for each day on which the violation occurs or failure to comply continues.
10	(d) (1) In addition to any other remedies available at law and after an opportunity for a hearing, which may be waived in writing by the person accused of a violation, the Department may impose a penalty for violation of any provision of this subtitle or any order, regulation, or plan adopted or issued under this subtitle.
12 13	(2) The penalty imposed on a supplier of water {serving a population of more than $\frac{10,000}{3,300}$ under this subsection shall be:
14 15	(i) Up to \$1,000 PER DAY for each violation, but not exceeding \$25,000 total FOR EACH VIOLATION; and
16	(ii) Assessed with consideration given to:
	1. The willfulness of the violation, the extent to which the existence of the violation was known to but uncorrected by the violator, and the extent to which the violator exercised reasonable care;
	2. Any actual harm to the environment or to human health, including injury to or impairment of the use of the waters of this State or the natural resources of the State;
23 24	The cost of cleanup and the cost of restoration of natural resources;
25 26	4. The nature and degree of injury to or interference with general welfare, health, and property;
	5. The extent to which the location of the violation, including location near waters of this State or areas of human population, creates the potential for harm to the environment or to human health or safety;
30 31	6. The available technology and economic reasonableness of controlling, reducing, or eliminating the violation;
32 33	7. The degree of hazard posed by the particular pollutant or pollutants involved;
	8. The extent to which the current violation is part of a recurrent pattern of the same or similar type of violation committed by the violator; and

19	(5) (I) THE DEPARTMENT MAY INCREASE THE PENALTY IMPOSED ON A SUPPLIER OF WATER SERVING A POPULATION OF 3,300 OR LESS, ON A CASE-BY-CASE BASIS, UP TO THE MAXIMUM PENALTIES SPECIFIED IN PARAGRAPH (2)(I) OF THIS SUBSECTION:
23	1. IF THE DEPARTMENT DETERMINES THAT THE PENALTIES SPECIFIED IN PARAGRAPH (3)(I) OR (4)(I) OF THIS SUBSECTION WILL NOT ADEQUATELY PROTECT THE INTERESTS OF THE STATE AND ENSURE COMPLIANCE WITH THIS SUBTITLE; AND

33 34	(4) (7) Any penalty imposed under this subsection is payable to the State and collectible in any manner provided at law for the collection of penalties.
35 36	(5) (8) All penalties collected under this subtitle shall be paid into the Maryland Clean Water Fund created under § 9-320 of this article.

- $1\,$ SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 2 effect October 1, 2001.
