- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:

- 21 and adequate compensation for the effort and duties required of the register by the
- 22 register's office.

- 1 (b) Each register is entitled to receive an annual salary of not less than (1) 2 [\$6,000] \$75,000 and not more than [\$75,000] \$85,000, to be determined in each 3 instance by the Board of Public Works. 4 In determining the annual salary of the register, the Board of Public 5 Works shall be guided in the exercise of its discretion by: 6 The population of the county determined by the last official (i) 7 United States census; The dollar volume of total fees and taxes collected and excess 8 (ii) 9 fees turned over to the State for each of the preceding 5 years by the office of the 10 register for which the salary is being fixed; and (iii) Other pertinent data which have relation to the reasonableness 12 of the salary in relation to the work done and volume handled by the office. SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, 13 14 Section 35 of the Constitution of Maryland, this Act may not be construed to extend or 15 apply to the salary or compensation of the register of wills in office on the effective
