- 9 abandonment of a patient; increasing certain curriculum content; prohibiting
- 10 certain misrepresentations; clarifying certain definitions; defining a term;
- 11 requiring that the Board adopt regulations to implement this Act on or before a
- 12 certain date; requiring the Board to submit certain reports by a certain date;
- 13 and generally relating to certified nursing assistants.
