1 AN ACT concerning

2 **Historic Motor Vehicles - Safety Equipment Repair Orders**

3 FOR the purpose of ~~requiring police officers to issue certain safety equipment repair~~  
4 ~~orders to drivers of certain historic motor vehicles that are being operated with~~  
5 ~~dangerous equipment or in a dangerous condition; requiring certain police~~  
6 ~~departments to issue repair order certifications to the owners of certain historic~~  
7 ~~motor vehicles~~ authorizing a police officer to issue a safety equipment repair  
8 order to a driver of a historic motor vehicle manufactured after a certain model  
9 year under certain circumstances; and generally relating to safety equipment  
10 repair orders for historic motor vehicles.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
22 MARYLAND, That the Laws of Maryland read as follows:

**Article - Transportation**

13-936.

(a) In this section, "historic motor vehicle" means a motor vehicle, including a passenger vehicle, motorcycle, or truck, that:

(1) Is 20 years old or older;

(2) Has not been substantially altered from the manufacturer's original design; and

(3) Meets criteria contained in rules and regulations issued by the Administration.

(b) In this section, "historic motor vehicle" does not include a vehicle that has been remanufactured or reconstructed as a replica of an original vehicle.

(c) If registered with the Administration under this section, every historic motor vehicle is a Class L (historic) vehicle.

(d) For each Class L (historic) vehicle, the annual registration fee is \$13.50.

(e) In applying for registration of a historic motor vehicle under this section, the owner of the vehicle shall submit with the application a certification that the vehicle for which the application is made:

(1) Will be maintained for use in exhibitions, club activities, parades, tours, occasional transportation, and similar uses; and

(2) Will not be used:

(i) For general daily transportation; or

(ii) Primarily for the transportation of passengers or property on highways.

(f) Except as provided in § 13-936.1 of this subtitle, on registration of a vehicle under this section, the Administration shall issue a special, historic motor vehicle registration plate of the size and design that the Administration determines.

(g) Unless the presence of the equipment was specifically required by a statute of this State as a condition of sale when the vehicle was manufactured, the presence of any specific equipment is not required for the operation of a vehicle registered under this section.

(h) A vehicle registered under this section is exempt from any statute that requires periodic vehicle inspections or that requires the use and inspection of emission controls.

2 (i) (1) "Vehicle" means, except as otherwise provided in this subsection, any  
3 vehicle registered or to be registered in this State as:

4 (i) A Class A (passenger) vehicle;

5 (ii) A Class M (multipurpose) vehicle;

6 (iii) A Class J (vanpool) vehicle;

7 (iv) A Class E (truck) vehicle;

8 (v) A Class F (tractor) vehicle;

9 (vi) A Class G (trailer) vehicle;

10 (vii) A Class B (for-hire) vehicle; or

11 (viii) A Class D (motorcycle) vehicle.

12 (2) For purposes of safety equipment repair orders only, "vehicle" means,  
13 except as provided in paragraph (3) of this subsection, any motor vehicle, trailer, or  
14 semitrailer.

16 MANUFACTURED BEFORE THE 1960 MODEL YEAR or} any trailer which is a mobile  
17 home as defined by § 11-134 of this article.

19 (a) (1) If a police officer observes that a vehicle registered in this State,  
20 ~~OTHER THAN A CLASS L (HISTORIC) VEHICLE,~~ is being operated with any equipment  
21 that apparently does not meet the standards established under this subtitle or the  
22 standards established under § 13-936 OR § 24-106.1(e) of this article, the officer shall  
23 stop the driver of the vehicle and issue to ~~him~~ ~~THE DRIVER~~ a safety equipment  
24 repair order.

25 (2) ~~IF A POLICE OFFICER OBSERVES THAT A CLASS L (HISTORIC)~~  
26 ~~VEHICLE IS BEING OPERATED WITH EQUIPMENT OR IN A CONDITION THAT THE~~  
27 ~~POLICE OFFICER REASONABLY BELIEVES IS DANGEROUS BECAUSE THE EQUIPMENT~~

32 ~~{(2)}~~ ~~(3)~~ A police officer may issue a safety equipment repair order for a  
33 cover required under § 24-106.1(e) of this article only if:

34 (i) The vehicle is equipped with a cover; and

1 (ii) The cover, or any equipment necessary to properly secure the  
2 cover, does not meet the standards established under § 24-106.1(e) of this article.

3 (b) The safety equipment repair order shall direct the owner of the vehicle:

4 (1) To have the equipment corrected as necessary at a place of the  
5 owner's choosing within 10 days from the issuance of the order; and

6 (2) To send to the Division a repair order certification dated subsequent  
7 to the issuance of the order.

8 (c) (1) If a safety equipment repair order is for equipment that can be  
9 certified as corrected or adequate by visual inspection and without the use of testing  
10 equipment, any police department that issues safety equipment repair orders and  
11 repair order certifications shall, on request of the owner:

12 (i) Visually inspect the vehicle; and

13 (ii) ~~{f} ISSUE A REPAIR ORDER CERTIFICATION IF:~~

19 (2) The Division shall determine the equipment that may be inspected  
20 visually under this subsection and shall adopt rules and regulations to carry out its  
21 provisions.

22 (d) The Division shall prepare and provide safety equipment repair order  
23 forms and repair order certification forms.

24 (e) (1) In cooperation with the Administration, the Division shall adopt  
25 rules and regulations to carry out the provisions of this section.

26 (2) The rules or regulations shall provide for:

27 (i) Suspending the registration of any vehicle for which a safety  
28 equipment repair order has been issued, on failure to comply with the order within 30  
29 days after its issuance; and

30 (ii) Reinstating the suspended registration, on receipt of  
31 satisfactory evidence that the equipment has been corrected or that the equipment  
32 meets or exceeds the standards established under this subtitle.

33 (f) This section does not limit or supersede any other provision of law  
34 concerning vehicle equipment or the means of enforcing the laws relating to that  
35 equipment.
