- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:

14 Article - Courts and Judicial Proceedings

- 16 (a) The sheriff of a county may establish and administer reasonable guidelines
- 17 in accordance with this section for disposing of abandoned, lawfully confiscated, or
- 18 recovered property that is in the possession of the sheriff's office.
- 19 (b) The guidelines shall provide that:
- 20 (1) [After] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION,
- 21 AFTER property has been in the possession of the sheriff for a period of one year,
- 22 notice of the sale of the property shall be given by registered or certified mail to those
- 23 persons entitled to its possession and to those lienholders whose names and addresses
- 24 can be ascertained by the exercise of reasonable diligence;
- 25 (2) The property may be sold at public auction after a description of the
- 26 property and the time, place, and terms of the sale have been published in a
- 27 newspaper of general circulation in the county in each of 2 successive weeks;

- 1 (3) The amount received from the sale of property in accordance with 2 this section shall be distributed in the following order of priority: To the sheriff, in an amount equal to the expense of the sale and (i) 4 all expenses incurred while the property was in the sheriff's custody; 5 (ii) To lienholders in order of their priority; and Subject to the provisions of item (4) of this subsection, to the 6 (iii) general fund of the county; and 8 At any time within 3 years from the date of the sale of the property, (4)
- 9 any person submitting satisfactory proof of the person's right to the possession of the 10 property shall be paid, without interest, the amount distributed to the general fund 11 pursuant to item (3) of this subsection, and after the expiration of 3 years from the
- 12 date of the sale, any claims shall be absolutely barred.
- 13 (C) IN HARFORD COUNTY, THE GUIDELINES ESTABLISHED UNDER THIS
 14 SECTION SHALL AUTHORIZE THE SHERIFF OF HARFORD COUNTY TO DISPOSE OF
 15 PROPERTY THAT HAS BEEN IN THE POSSESSION OF THE SHERIFF'S OFFICE FOR
 16 MORE THAN 90 DAYS.
- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 2001.
