- 17 MARYLAND, That the Laws of Maryland read as follows:

- 20 (b) The sales and use tax does not apply to a sale of:
- 21 (17) a wig or hairpiece needed as a result of documented medical or
- 22 surgical treatment; [or]
- 23 (18) nicotine patches, nicotine gum, or any other product intended for use
- 24 as an aid in tobacco use cessation and approved by the United States Food and Drug
- 25 Administration for that purpose[.]; OR

- 1 (19) TANGIBLE PERSONAL PROPERTY THAT IS MANUFACTURED FOR THE
- 2 PURPOSE OF INITIATING, SUPPORTING, OR SUSTAINING BREAST-FEEDING,
- 3 INCLUDING BREAST PUMPS, BREAST PUMP KITS, NIPPLE ENHANCERS, BREAST
- 4 SHIELDS, BREAST SHELLS, SUPPLEMENTAL NURSING SYSTEMS, SOFTCUP FEEDERS,
- 5 FEEDING TUBES, BREAST MILK STORAGE BAGS, PERIODONTAL SYRINGES, FINGER
- 6 FEEDERS, HABERMAN FEEDERS, AND PURIFIED LANOLIN.
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 8 July 1, 2001.
