[A] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, A local 18 (a) 19 authority may not issue a residential parking permit to the owner of a vehicle to be 20 valid for a period in excess of 30 days unless the owner provides satisfactory evidence 21 that: 22 The vehicle for which the parking permit is sought is registered in (1) 23 the State: or 24 (2)The owner of the vehicle has obtained under § 13-402.1 of this 25 article:

A nonresident permit; or

A complimentary guest card.

- 1 (b) If a residential parking permit area is established as a result of the
- 2 construction of a professional sports facility that seats 45,000 or more people, a local
- 3 authority may not charge a fee for the issuance of a permit to park in that area.
- 4 (C) IN BALTIMORE CITY, THE DIRECTOR OF THE BALTIMORE CITY
- 5 DEPARTMENT OF PUBLIC WORKS MAY ISSUE, ON A CASE BY CASE BASIS, A
- 6 RESIDENTIAL PARKING PERMIT TO A PERSON WHO OWNS RESIDENTIAL PROPERTY
- 7 IN THE RESIDENTIAL PARKING PERMIT AREA REGARDLESS OF WHETHER THE
- 8 PERSON WOULD OTHERWISE QUALIFY FOR A RESIDENTIAL PARKING PERMIT UNDER
- 9 SUBSECTION (A) OF THIS SECTION.
- 10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 11 October 1, 2001.
