A BILL ENTITLED

1 AN ACT concerning

- Creation of a State Debt Charles County Old Waldorf School Community
 Center and Head Start Facility
- 4 FOR the purpose of authorizing the creation of a State Debt not to exceed \$350,000,
- 5 the proceeds to be used as a grant to the Board of Directors of the Friends of Old
- 6 Waldorf School Foundation, Inc. for certain development or improvement
- 7 purposes; requiring the grantee to grant and convey a certain easement to the
- 8 Maryland Historical Trust; providing for disbursement of the loan proceeds,
- 9 subject to a requirement that the grantee provide and expend a matching fund;
- and providing generally for the issuance and sale of bonds evidencing the loan.
- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 12 MARYLAND, That:
- 13 (1) The Board of Public Works may borrow money and incur indebtedness on
- 14 behalf of the State of Maryland through a State loan to be known as the Charles
- 15 County Old Waldorf School Community Center and Head Start Facility Loan of
- 16 2001 in a total principal amount equal to the lesser of (i) \$350,000 or (ii) the amount
- 17 of the matching fund provided in accordance with Section 1(5) below. This loan shall
- 18 be evidenced by the issuance, sale, and delivery of State general obligation bonds
- 19 authorized by a resolution of the Board of Public Works and issued, sold, and
- 20 delivered in accordance with §§ 8-117 through 8-124 of the State Finance and
- 21 Procurement Article and Article 31, § 22 of the Code.
- 22 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 23 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 24 § 8-122 of the State Finance and Procurement Article.
- 25 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 26 and first shall be applied to the payment of the expenses of issuing, selling, and
- 27 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 28 shall be credited on the books of the Comptroller and expended, on approval by the
- 29 Board of Public Works, for the following public purposes, including any applicable
- 30 architects' and engineers' fees: as a grant to the Board of Directors of the Friends of
- 31 Old Waldorf School Foundation, Inc. (referred to hereafter in this Act as "the
- 32 grantee") for the repair, renovation, reconstruction, and capital equipping of the Old

- 1 Waldorf School for use as a community center and Head Start facility, located in 2 Waldorf, Maryland.
- 3 (4) An annual State tax is imposed on all assessable property in the State in 4 rate and amount sufficient to pay the principal of and interest on the bonds, as and
- 5 when due and until paid in full. The principal shall be discharged within 15 years
- 6 after the date of issuance of the bonds.
- 7 (5) Prior to the payment of any funds under the provisions of this Act for the
- $8\,$ purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 9 matching fund. No part of the grantee's matching fund may be provided, either
- 10 directly or indirectly, from funds of the State, whether appropriated or
- 11 unappropriated. No part of the fund may consist of real property. The fund may
- 12 consist of in kind contributions or funds expended prior to the effective date of this
- 13 Act. In case of any dispute as to the amount of the matching fund or what money or
- 14 assets may qualify as matching funds, the Board of Public Works shall determine the
- 15 matter and the Board's decision is final. The grantee has until June 1, 2003, to
- 16 present evidence satisfactory to the Board of Public Works that a matching fund will
- 17 be provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 18 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 19 equal to the amount of the matching fund shall be expended for the purposes provided
- 20 in this Act. Any amount of the loan in excess of the amount of the matching fund
- 21 certified by the Board of Public Works shall be canceled and be of no further effect.
- 22 (6) (a) Prior to the issuance of the bonds, the grantee shall grant and convey
- 23 to the Maryland Historical Trust a perpetual preservation easement to the extent of
- 24 its interest:
- 25 (i) On the land or such portion of the land acceptable to the Trust;
- 26 and
- 27 (ii) On the exterior and interior, where appropriate, of the historic
- 28 structures.
- 29 (b) If the grantee or beneficiary of the grant holds a lease on the land
- 30 and structures, the Trust may accept an easement on the leasehold interest.
- 31 (c) The easement must be in form and substance acceptable to the Trust
- 32 and any liens or encumbrances against the land or the structures must be acceptable
- 33 to the Trust.
- 34 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 35 June 1, 2001.
