2 Transportation - Maryland Pedestrian Safety Fund

- 3 FOR the purpose of establishing the Maryland Pedestrian Safety Fund; requiring the
- 4 Secretary of Transportation to award grants from the Fund to counties,
- 5 municipalities, and nonprofit organizations; requiring the Secretary to establish
- 6 certain grant application procedures; authorizing counties, municipalities, and
- 7 nonprofit organizations to apply for grants from the Fund to be used for certain
- 8 purposes relating to pedestrian safety; and generally relating to the Maryland
- 9 Pedestrian Safety Fund.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article - Transportation**

- 19 (A) IN THIS SECTION, "FUND" MEANS THE MARYLAND PEDESTRIAN SAFETY
- 20 FUND.
- 21 (B) THERE IS A PEDESTRIAN SAFETY FUND WITHIN THE DEPARTMENT.
- 22 (C) (1) THE FUND IS A CONTINUING, NONLAPSING FUND THAT IS NOT
- 23 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.
- 24 (2) THE TREASURER SHALL SEPARATELY HOLD AND THE COMPTROLLER
- 25 SHALL ACCOUNT FOR THE FUND.

- 1 (3) THE TREASURER SHALL INVEST THE FUND IN THE SAME MANNER AS 2 OTHER STATE FUNDS AND CREDIT ANY INVESTMENT EARNINGS TO THE FUND.
- 3 (D) THE FUND CONSISTS OF:
- 4 (1) MONEYS APPROPRIATED IN THE STATE BUDGET TO THE FUND;
- 5 (2) EARNINGS FROM THE INVESTMENT OF MONEYS IN THE FUND; AND
- 6 (3) ANY OTHER MONEYS ACCEPTED FOR THE BENEFIT OF THE FUND 7 FROM ANY GOVERNMENTAL OR PRIVATE SOURCE.
- 8 (E) (1) THE SECRETARY SHALL AWARD GRANTS FROM THE FUND TO 9 COUNTIES, MUNICIPALITIES, AND NONPROFIT ORGANIZATIONS TO CARRY OUT THE 10 PROVISIONS OF THIS SECTION.
- 11 (2) WHEN AWARDING GRANTS FROM THE FUND, THE SECRETARY SHALL 12 CONSIDER ANY MATCHING FUND AN APPLICANT PROPOSES TO PROVIDE.
- 13 (F) COUNTIES, MUNICIPALITIES, AND NONPROFIT ORGANIZATIONS MAY 14 APPLY FOR GRANTS FROM THE FUND FOR THE FOLLOWING PURPOSES:
- 15 (1) TO EDUCATE AUTOMOBILE DRIVERS AND PEDESTRIANS ABOUT 16 METHODS TO INCREASE PEDESTRIAN SAFETY;
- 17 (2) TO ENHANCE EFFORTS TO ENFORCE STATE AND LOCAL MOTOR 18 VEHICLE LAWS THAT PROTECT THE SAFETY OF PEDESTRIANS; AND
- 19 (3) TO DESIGN OR REDESIGN INTERSECTIONS TO INCREASE 20 PEDESTRIAN SAFETY AND ACCESS.
- 21 (G) THE SECRETARY SHALL ESTABLISH PROCEDURES FOR COUNTIES,
- 22 MUNICIPALITIES, AND NONPROFIT ORGANIZATIONS TO APPLY FOR GRANTS FROM
- 23 THE FUND.
- 24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 25 October 1, 2001.
