- 1 (3) The executive secretary and the deputy executive secretary shall be 2 residents of Baltimore City and of high character and integrity.
- 3 (4) The executive secretary and the deputy executive secretary shall be
- 4 appointed upon the basis of their executive skill and ability and once appointed shall
- 5 hold office during good behavior regardless of changes in members constituting the
- 6 Board. They shall be removed only for incompetency or immorality upon charges
- 7 furnished in writing by the Board setting forth the grounds for dismissal and after
- 8 opportunity for hearing.
- 9 (5) Either the executive secretary or the deputy executive secretary shall 10 be a member of the Bar of this State.
- 11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 12 October 1, 2001.
