A BILL ENTITLED

1 AN ACT concerning

2 **Senior Lifetime Sport Fishing License and Endowment Fund**

3 FOR the purpose of establishing a resident consolidated Senior Lifetime Sport
4 Fishing License; establishing the fee for the license and the means by which the
5 license may be obtained; establishing the rights of a holder of the license;
6 establishing a nonlapsing Senior Lifetime Sport Fishing License Fund into
7 which fees collected for the license are to be deposited; providing that money
8 may be withdrawn from the Fund only at certain times and for certain purposes;
9 and generally relating to the resident consolidated Senior Lifetime Sport
10 Fishing License and the Senior Lifetime Sport Fishing License Fund.

13 Section 4-216.1 and 4-216.2

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article - Natural Resources**

19 4-216.1.

20 (A) THE DEPARTMENT SHALL ESTABLISH A RESIDENT CONSOLIDATED
21 SENIOR LIFETIME SPORT FISHING LICENSE TO BE ISSUED TO RESIDENTS OF
22 MARYLAND BEGINNING IN THE CALENDAR YEAR IN WHICH THEY BECOME 65 YEARS
23 OF AGE.

24 (B) (1) THE RESIDENT CONSOLIDATED SENIOR LIFETIME SPORT FISHING
25 LICENSE MAY BE OBTAINED FROM THE DEPARTMENT OR FROM ANY AUTHORIZED
26 AGENT OF THE DEPARTMENT.

27 (2) THE ONE-TIME FEE FOR THE LICENSE IS \$25.

1 (3) AS COMPENSATION, AN AGENT SHALL RETAIN 50 CENTS FOR EACH
2 LICENSE ISSUED.

3 (C) A RESIDENT CONSOLIDATED SENIOR LIFETIME SPORT FISHING LICENSE
4 SHALL BE VALID FOR THE DURATION OF THE LIFETIME OF THE HOLDER.

5 (D) A HOLDER OF A RESIDENT CONSOLIDATED SENIOR LIFETIME SPORT
6 FISHING LICENSE MAY:

7 (1) ENGAGE IN ANGLING ON THE NONTIDAL WATERS OF THE STATE
8 WITHOUT HOLDING AN ANGLER'S LICENSE UNDER § 4-604 OF THIS TITLE;

9 (2) ENGAGE IN ANGLING FOR TROUT ON THE NONTIDAL WATERS OF
10 THE STATE WITHOUT HOLDING A TROUT STAMP UNDER § 4-614 OF THIS TITLE; AND

11 (3) FISH FOR FINFISH IN THE CHESAPEAKE BAY AND ITS TRIBUTARIES
12 WITHOUT HOLDING A CHESAPEAKE BAY SPORT FISHING LICENSE UNDER § 4-745 OF
13 THIS TITLE.

14 (E) ALL FEES COLLECTED BY THE DEPARTMENT UNDER THIS SECTION MAY
15 ONLY BE USED IN ACCORDANCE WITH § 4-216.2 OF THIS SUBTITLE.

16 4-216.2.

17 (A) THERE IS A SENIOR LIFETIME SPORT FISHING LICENSE FUND IN THE
18 DEPARTMENT.

19 (B) THE SENIOR LIFETIME SPORT FISHING LICENSE FUND IS A CONTINUING,
20 NONLAPSING FUND, NOT SUBJECT TO § 7-302 OF THE STATE FINANCE AND
21 PROCUREMENT ARTICLE.

22 (C) ANY MONEY RECEIVED FROM ANY LICENSE AS PROVIDED IN § 4-216.1 OF
23 THIS SUBTITLE SHALL BE CREDITED TO THE FUND.

24 (D) MONEY MAY BE WITHDRAWN FROM THE FUND ONLY AS AN ANNUAL
25 APPROPRIATION.

26 (E) MONEY WITHDRAWN FROM THE FUND SHALL BE USED ONLY FOR THE
27 PROTECTION, MANAGEMENT, INVESTIGATION, OR REPLENISHMENT OF TIDAL OR
28 NONTIDAL FINFISH FOR THE ENHANCEMENT OF RECREATIONAL FISHING.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
30 October 1, 2001.
