- 1 (I) RECEIVING A SERVICE RETIREMENT ALLOWANCE OR A VESTED 2 ALLOWANCE FROM THE STATE POLICE RETIREMENT SYSTEM; AND
- 3 (II) SERVING AS A SHERIFF OR STATE'S ATTORNEY FOR A COUNTY 4 THAT IS A PARTICIPATING GOVERNMENTAL UNIT.
- 5 (2) A member is not entitled to receive a pension or retirement allowance
- 6 from another pension or retirement system supported wholly or in part by the State.
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
- 8 construed retroactively and shall be applied to and interpreted to affect any
- 9 individual who was serving as a sheriff or State's Attorney on or after January 4, 1999
- 10 and is serving in that same position on July 1, 2001.
- 11 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 12 July 1, 2001.
