- 3 FOR the purpose of prohibiting a person from selling, dispensing, or offering to sell or
- 4 dispense a tobacco product through certain vending machines unless the person
- 5 submits a certain affidavit of compliance; specifying certain recipients of certain
- 6 affidavits; and generally relating to a certain prohibition on the sale, dispensing,
- 7 or offering to sell or dispense tobacco products through certain vending
- 8 machines unless a certain affidavit of compliance has been submitted.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

16 Article - Business Regulation

- 18 (A) A person may not sell or dispense or offer to sell or dispense a tobacco
- 19 product through a vending machine in the State, unless the vending machine:
- 20 (1) is located in an establishment that minors are prohibited by law from
- 21 entering or an establishment that is a bona fide fraternal or veterans organization; or
- 22 (2) can only be operated with a token, card, or similar device that an
- 23 individual can only obtain or purchase from the owner or an employee or agent of the
- 24 owner.
- 25 (B) (1) A PERSON MAY NOT SELL, DISPENSE, OR OFFER TO SELL OR
- 26 DISPENSE A TOBACCO PRODUCT UNDER SUBSECTION (A)(2) OF THIS SECTION
- 27 UNLESS THE PERSON SUBMITS A NOTARIZED AFFIDAVIT OF COMPLIANCE WITH
- 28 SUBSECTION (A)(2) OF THIS SECTION STATING THAT:

- 1 (I) THE OPERATION OF THE VENDING MACHINE HAS BEEN 2 CONVERTED TO A TOKEN, CARD, OR SIMILAR DEVICE; OR
- 3 (II) THE VENDING MACHINE WAS MANUFACTURED TO OPERATE 4 ONLY WITH A TOKEN, CARD, OR SIMILAR DEVICE.
- 5 (2) A PERSON REQUIRED UNDER PARAGRAPH (1) OF THIS SUBSECTION 6 TO SUBMIT A NOTARIZED AFFIDAVIT SHALL SUBMIT THE AFFIDAVIT TO:
- 7 (I) THE COMPTROLLER, IF THE PERSON IS LICENSED OR APPLYING 8 FOR A LICENSE UNDER SUBTITLE 2 OF THIS TITLE; AND
- 9 (II) THE CLERK, IF THE PERSON IS LICENSED OR APPLYING FOR A 10 LICENSE UNDER SUBTITLE 3 OF THIS TITLE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 October 1, 2001.
