- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:
- 15 **Chapter 182 of the Acts of 1999**
- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That:
- 18 (5) Prior to the payment of any funds under the provisions of this Act for
- 19 the purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 20 matching fund. No part of the grantee's matching fund may be provided, either
- 21 directly or indirectly, from funds of the State, whether appropriated or
- 22 unappropriated. No part of the fund may consist of in kind contributions. The
- 23 matching fund may consist of real property or funds expended prior to the effective
- 24 date of this Act. In case of any dispute as to the amount of the matching fund or what
- 25 money or assets may qualify as matching funds, the Board of Public Works shall
- 26 determine the matter and the Board's decision is final. The grantee has until June 1,
- 27 [2001] 2002, to present evidence satisfactory to the Board of Public Works that a
- 28 matching fund will be provided. If satisfactory evidence is presented, the Board shall
- 29 certify this fact and the amount of the matching fund to the State Treasurer, and the
- 30 proceeds of the loan equal to the amount of the matching fund shall be expended for
- 31 the purposes provided in this Act. Any amount of the loan in excess of the amount of

- $1\,$  the matching fund certified by the Board of Public Works shall be canceled and be of  $2\,$  no further effect.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 4 June 1, 2001.
